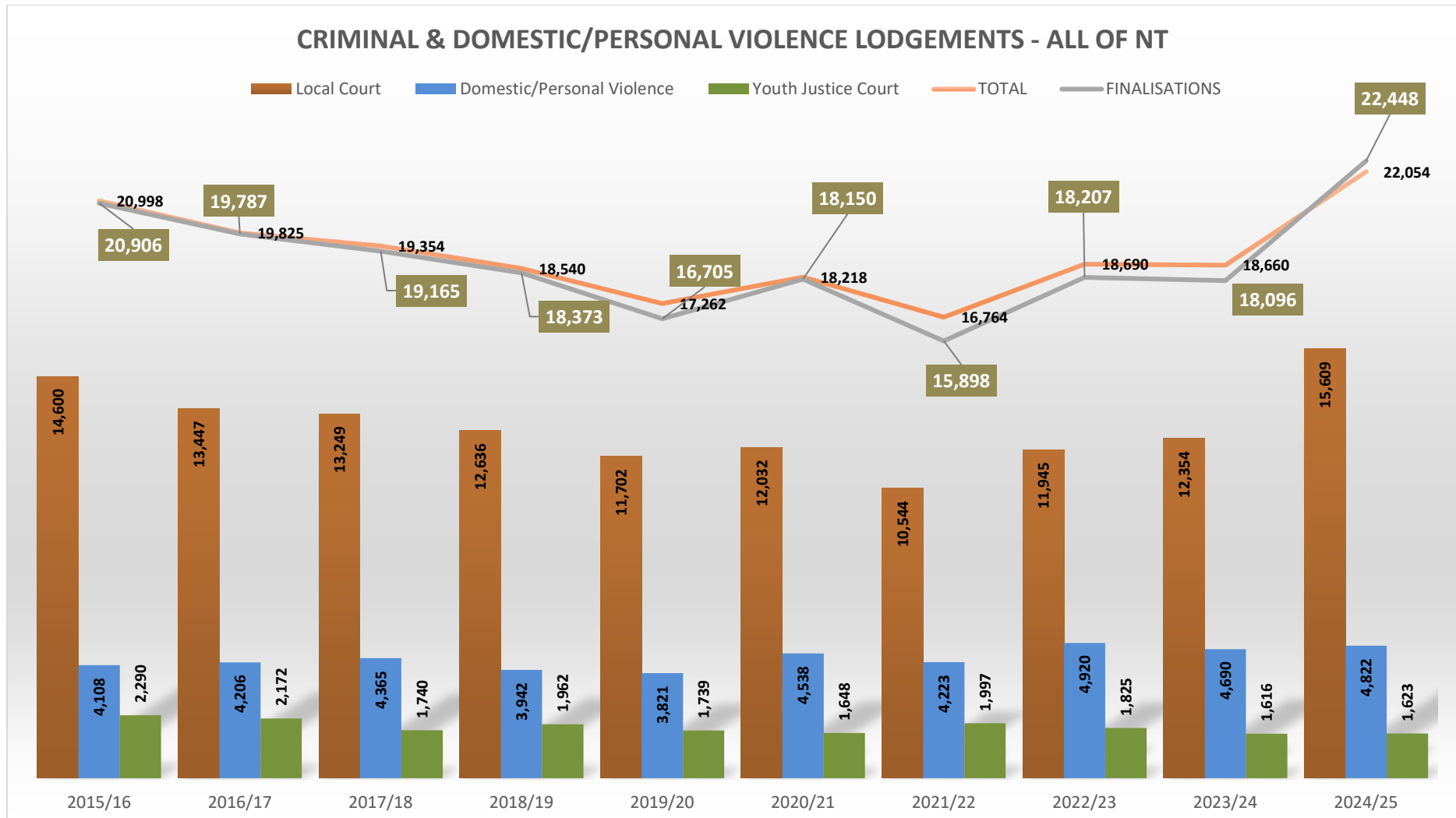


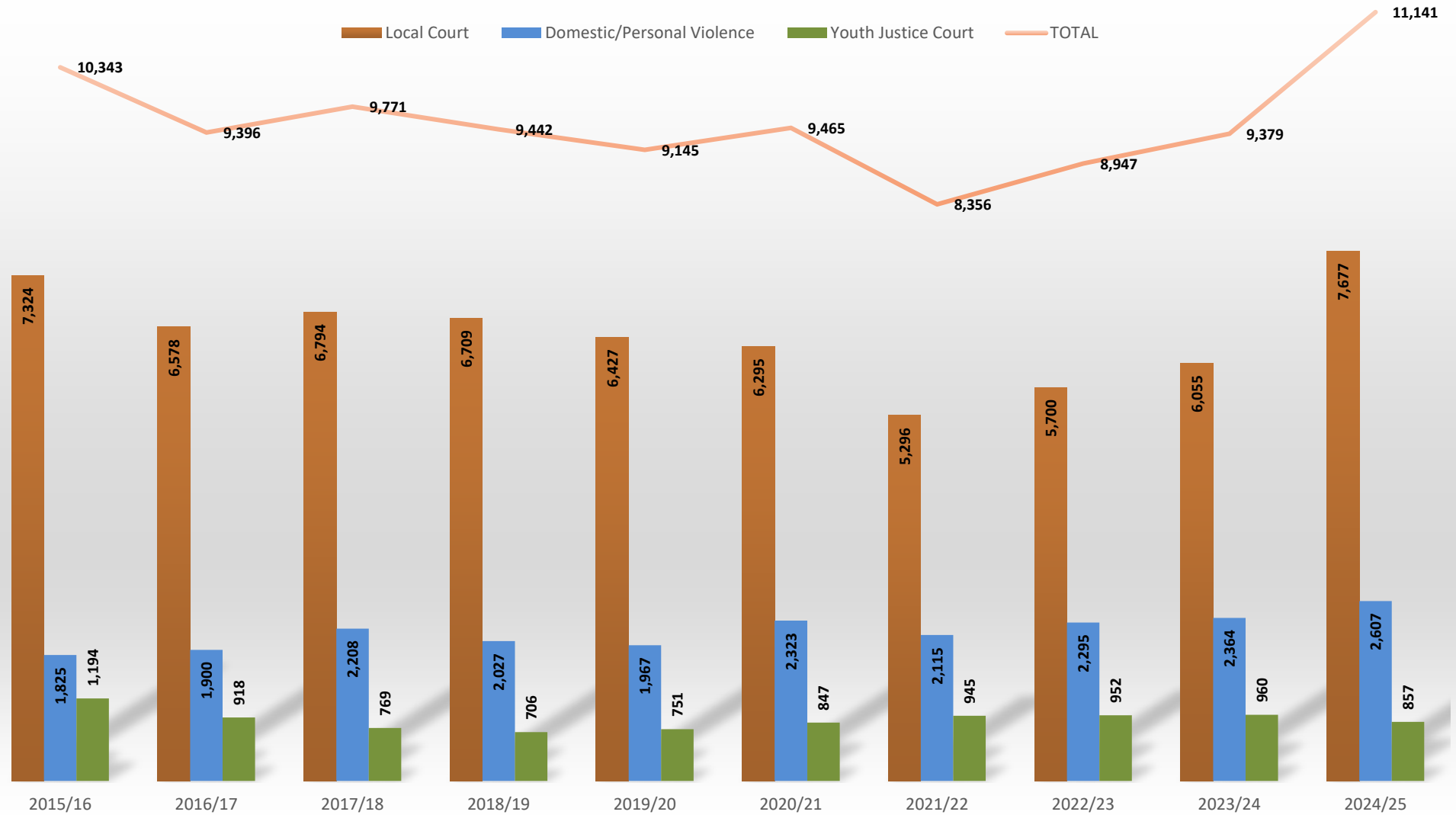

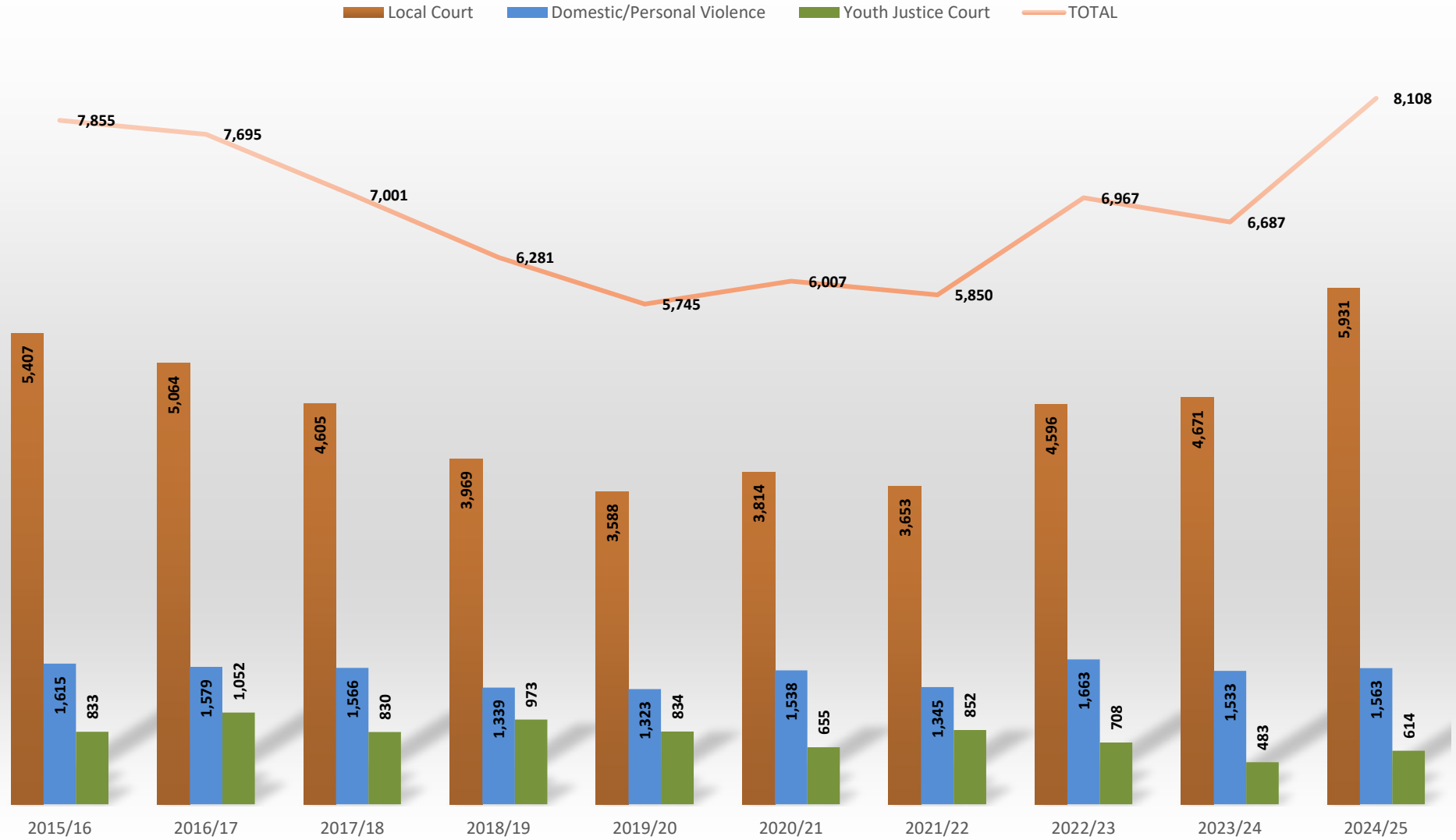

CRIMINAL & DOMESTIC/PERSONAL VIOLENCE LODGEMENTS - DARWIN REGION

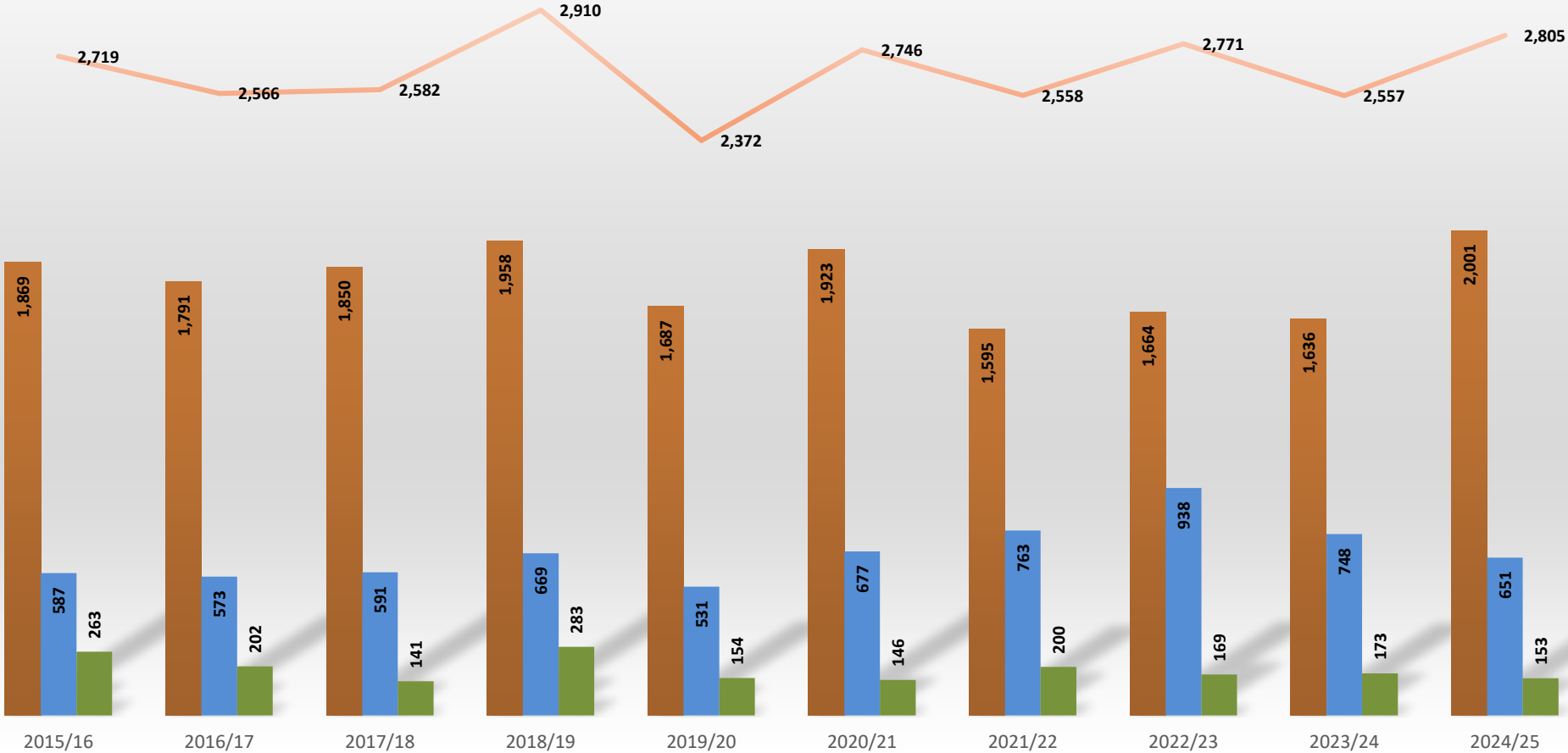


CRIMINAL & DOMESTIC/PERSONAL VIOLENCE LODGEMENTS - ALICE SPRINGS/BARKLY REGION



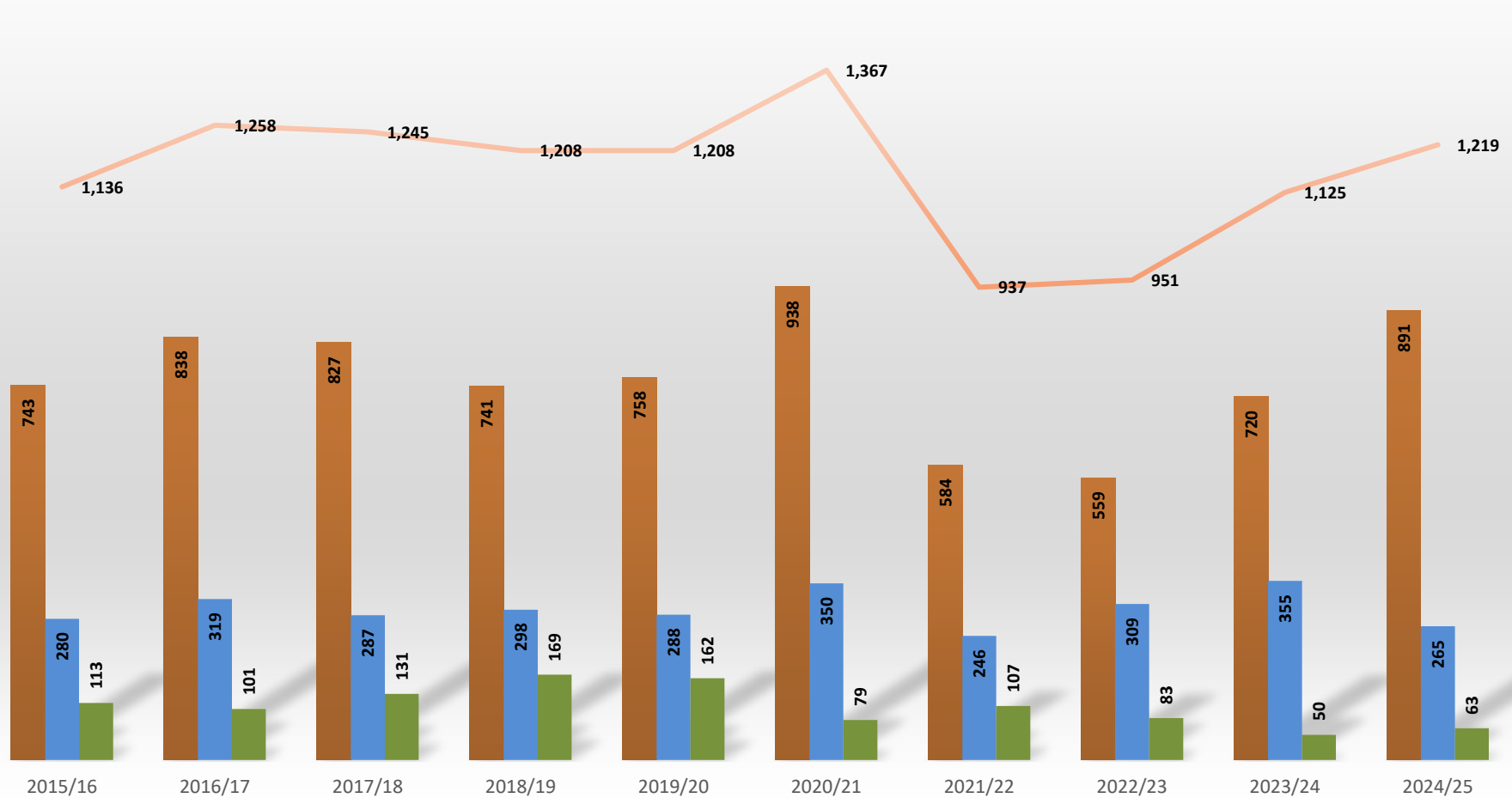
CRIMINAL & DOMESTIC/PERSONAL VIOLENCE LODGEMENTS - KATHERINE REGION

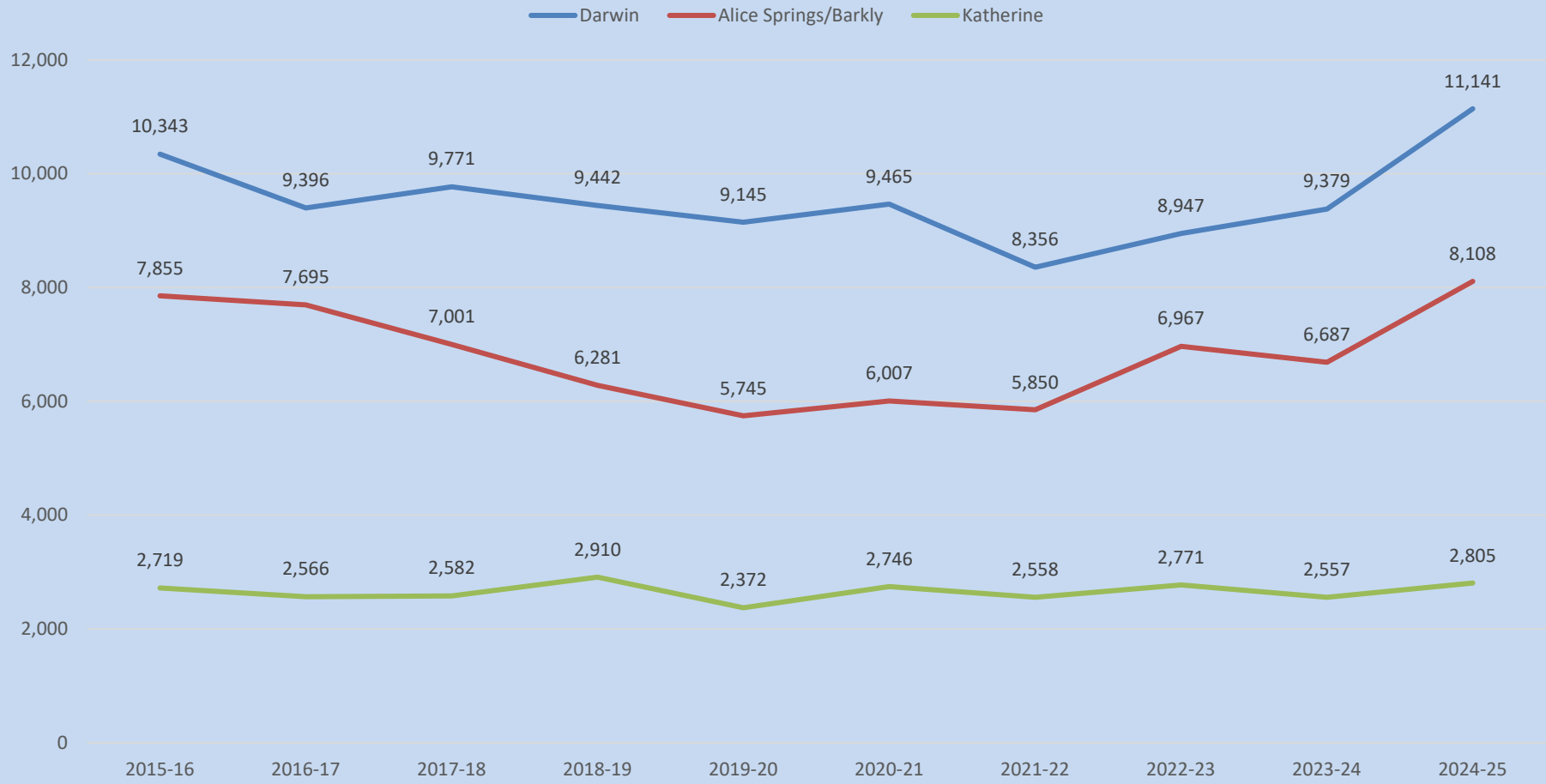

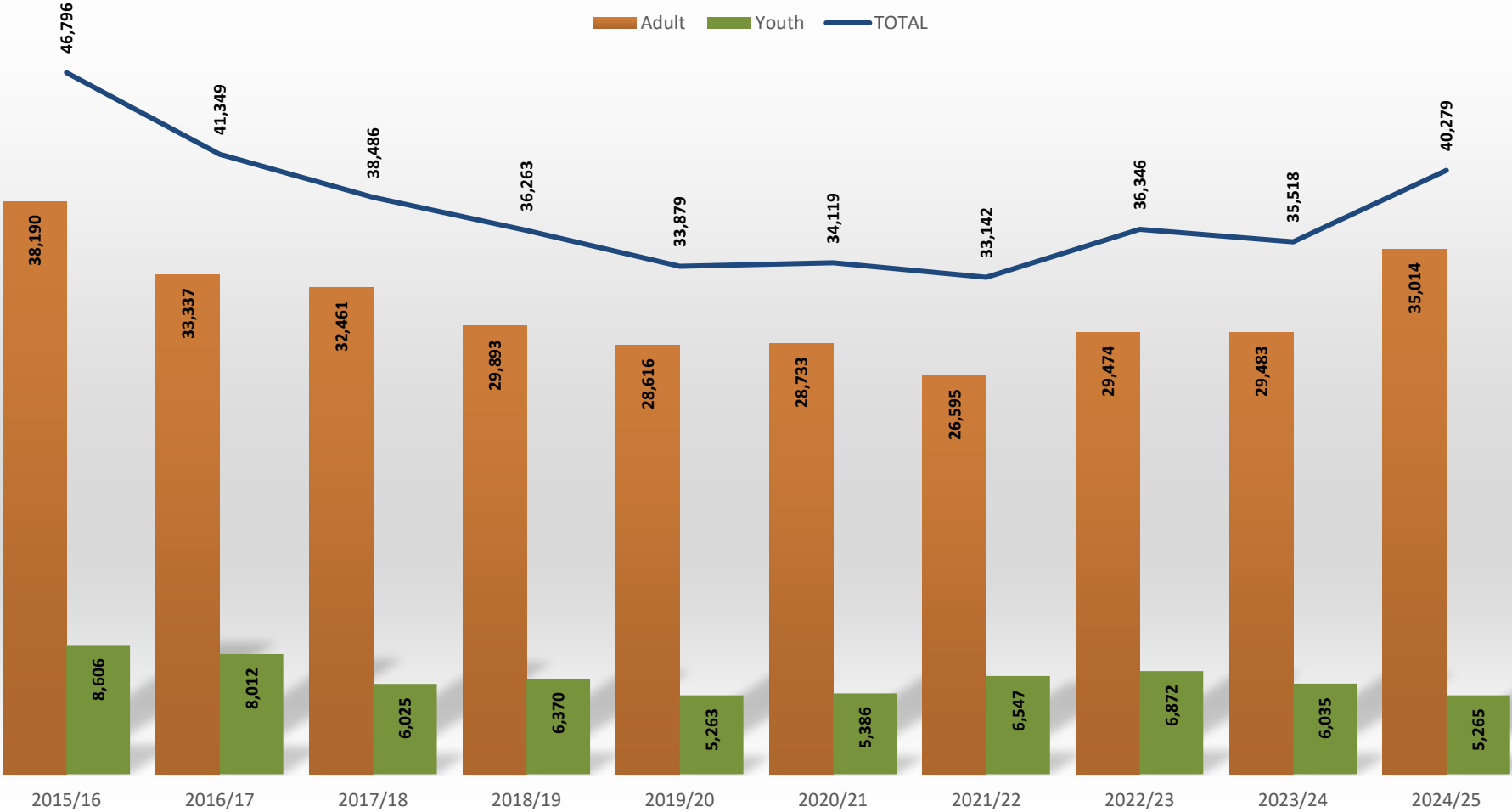


LOWER COURTS CRIMINAL & DOMESTIC/PERSONAL VIOLENCE LODGEMENTS - BY REGION

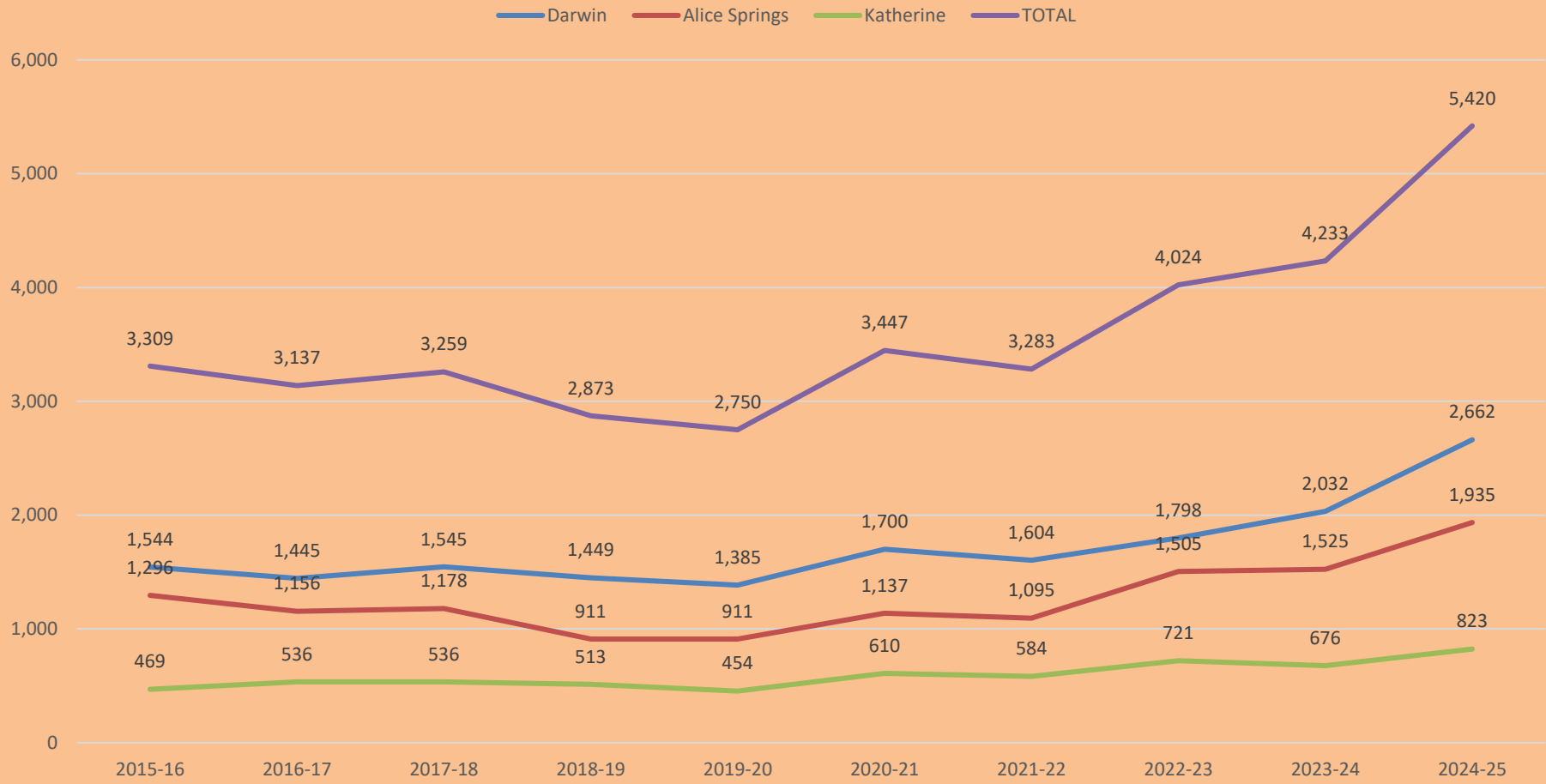

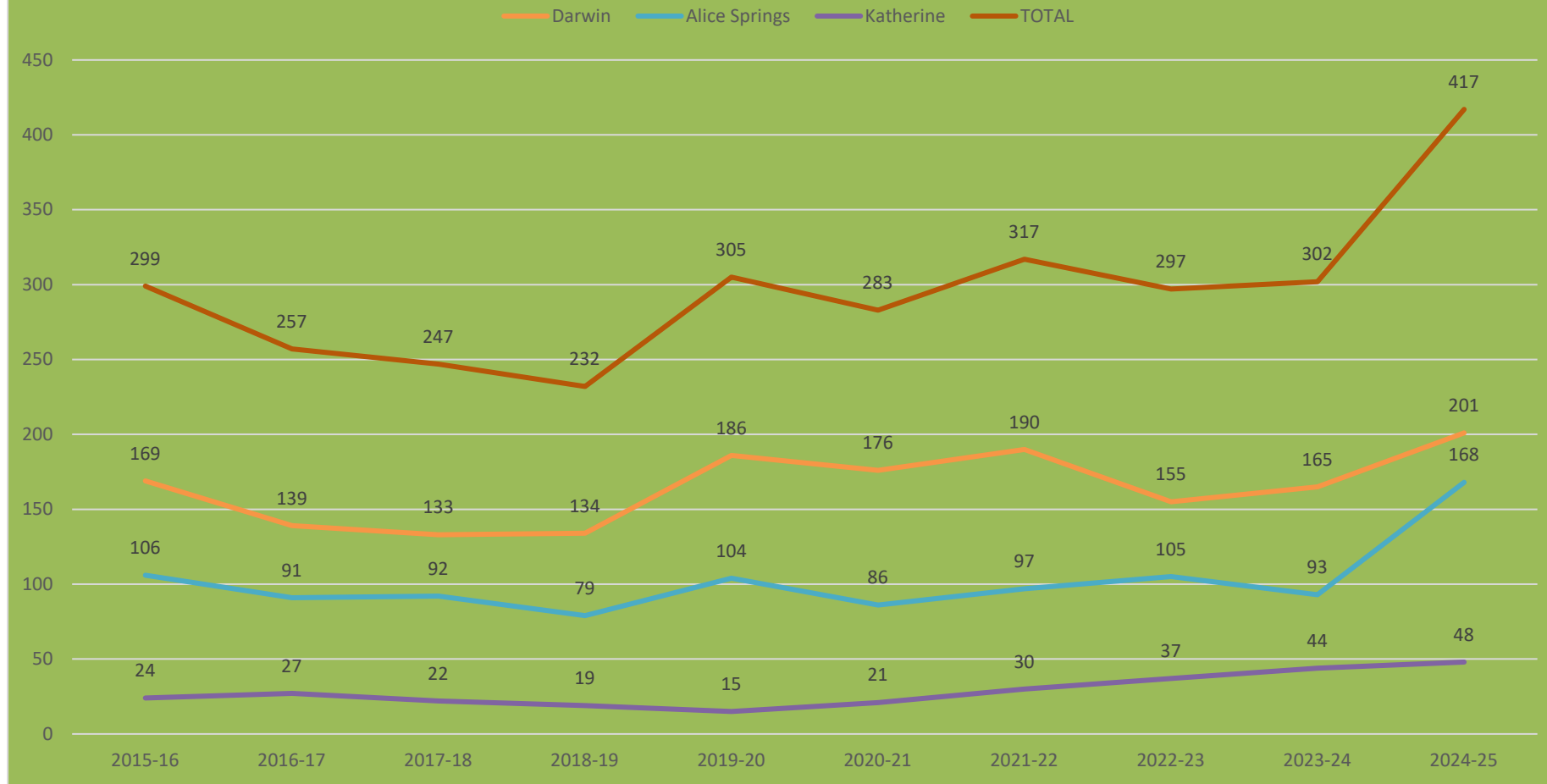

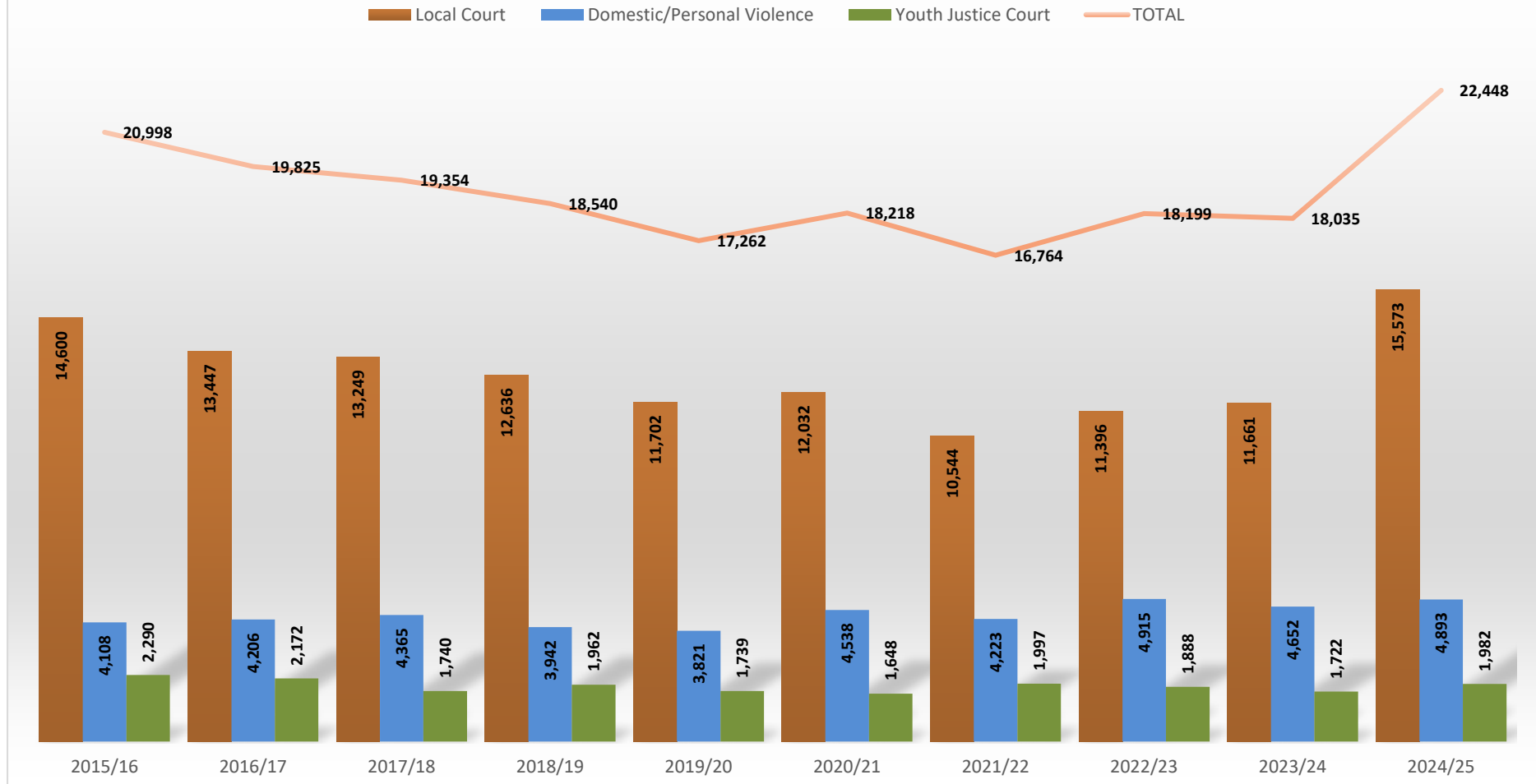
LOCAL COURT (ADULT) LODGEMENTS - ASSAULTS



YOUTH JUSTICE COURT LODGEMENTS - ASSAULTS

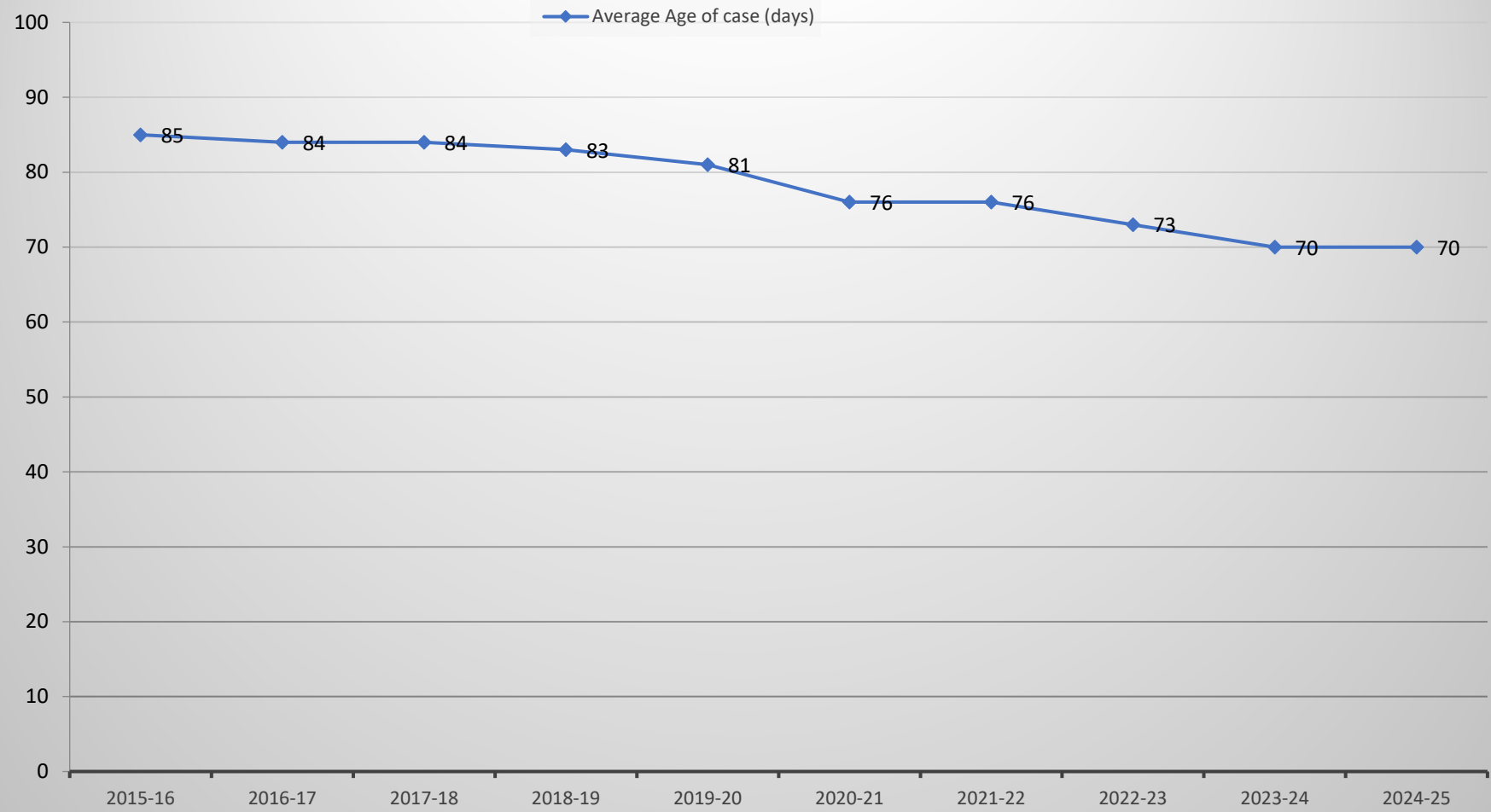

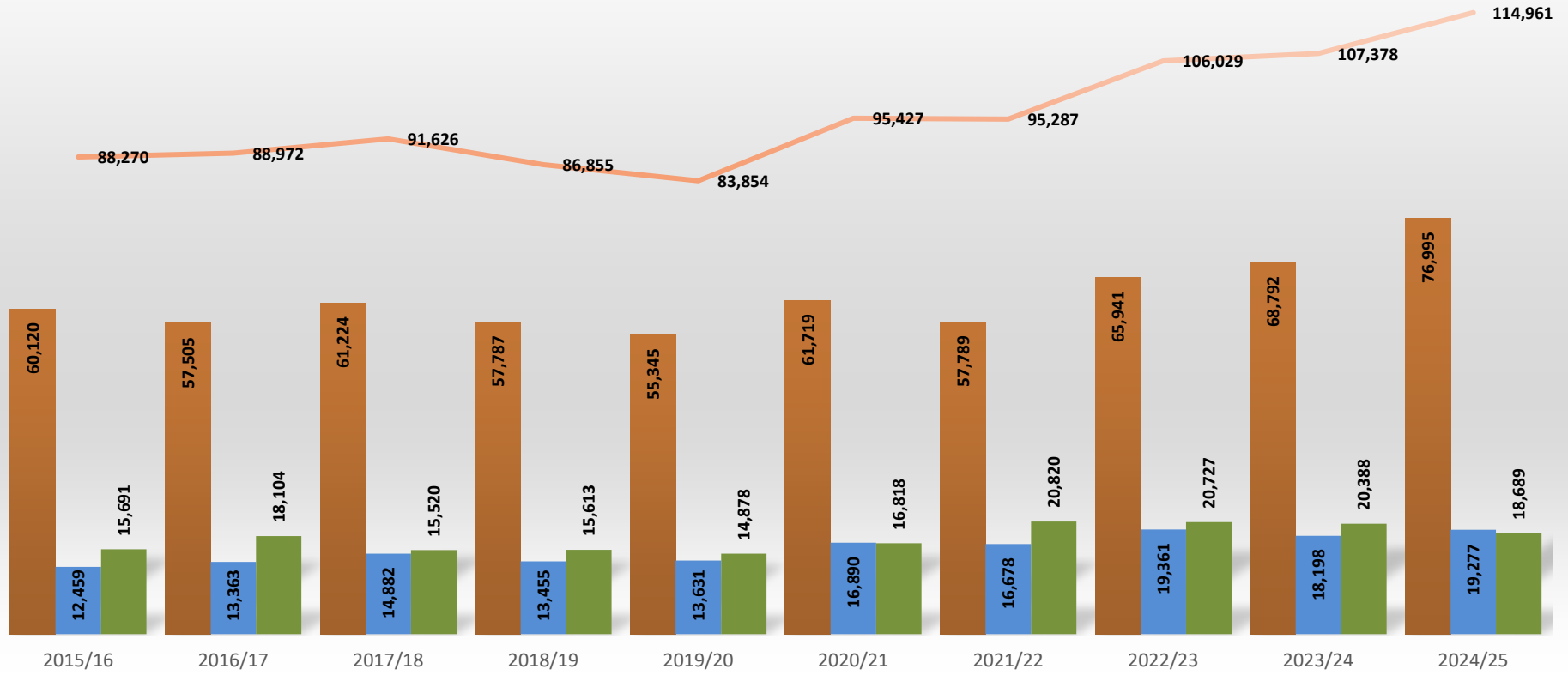

Local Court % of criminal matters finalised within six months



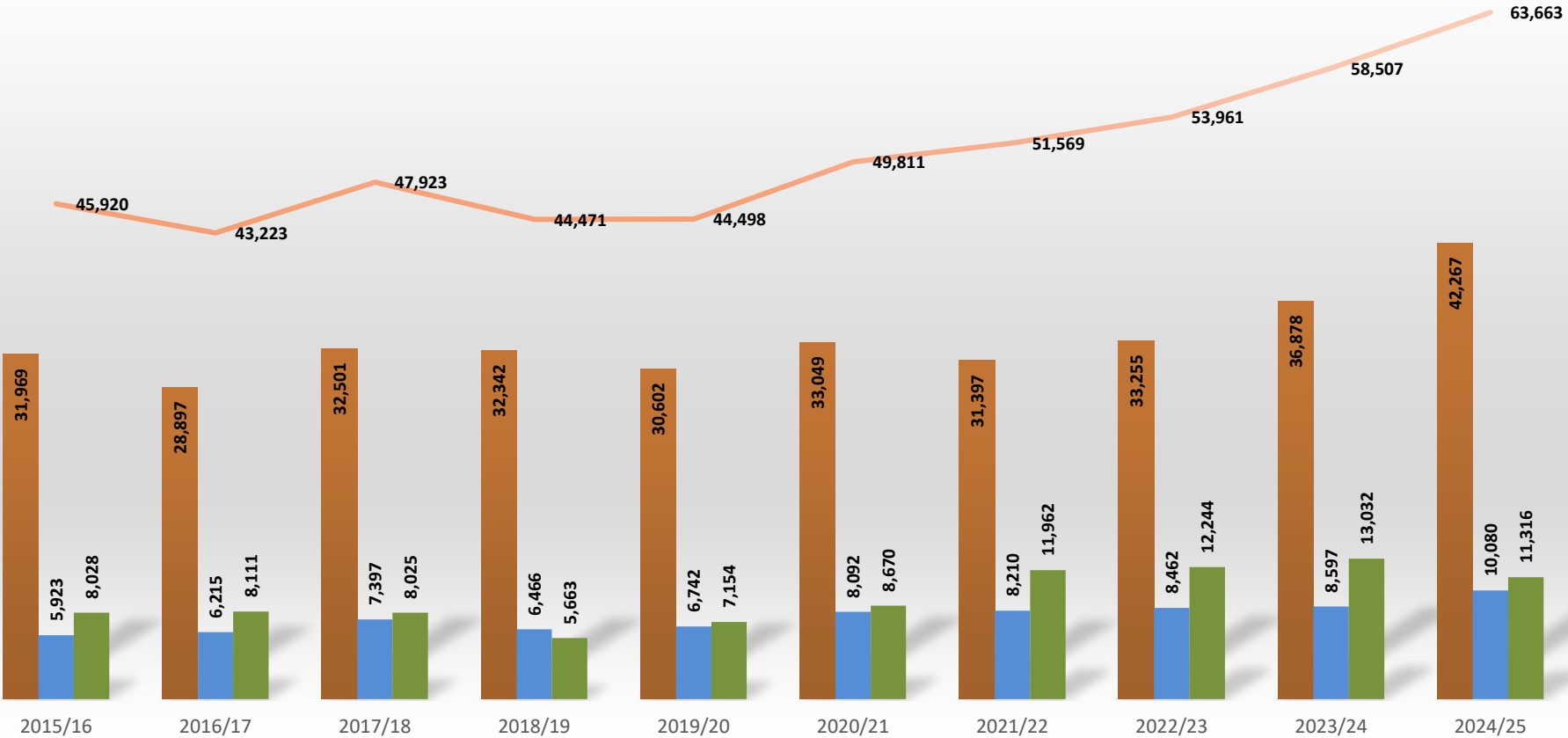

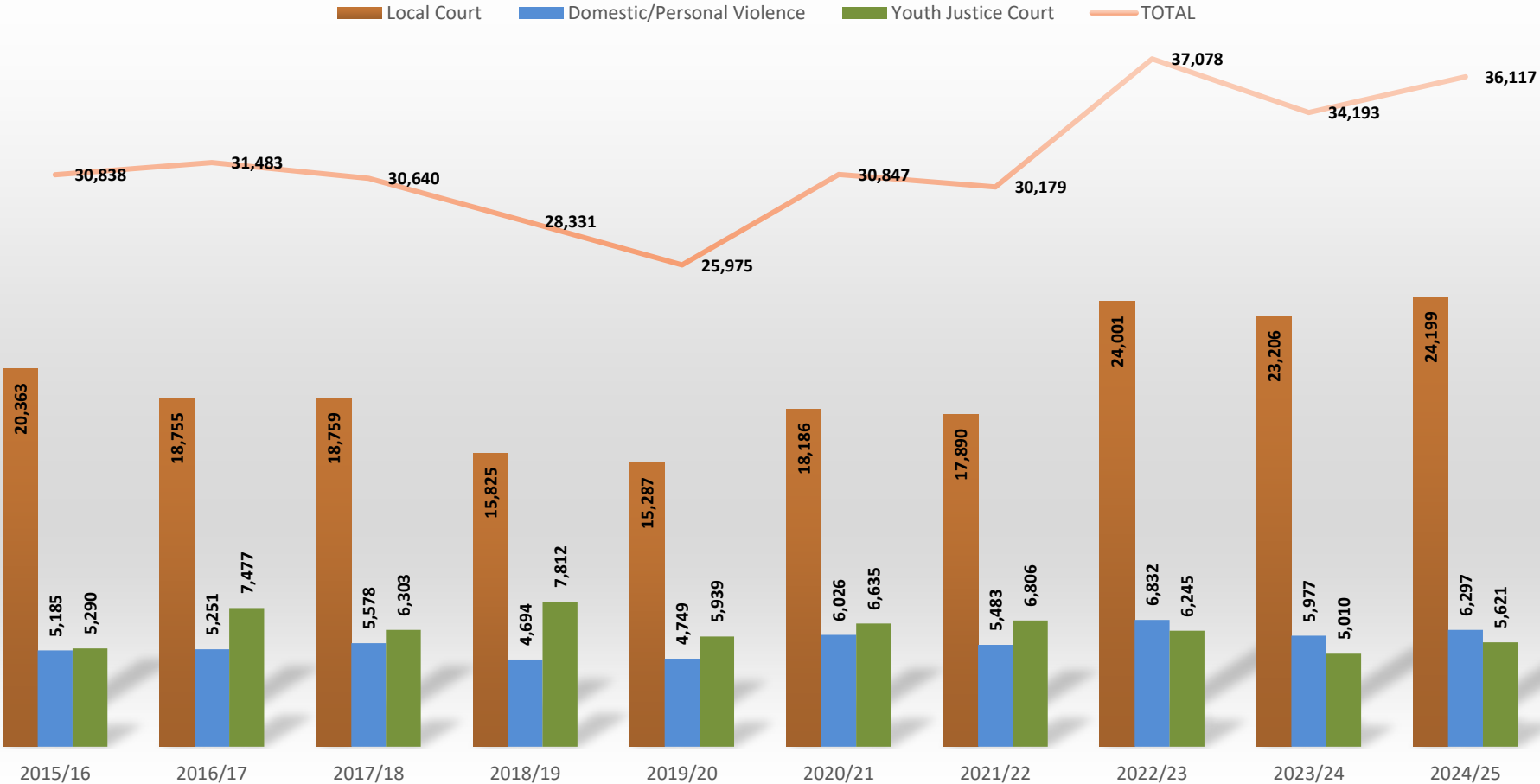

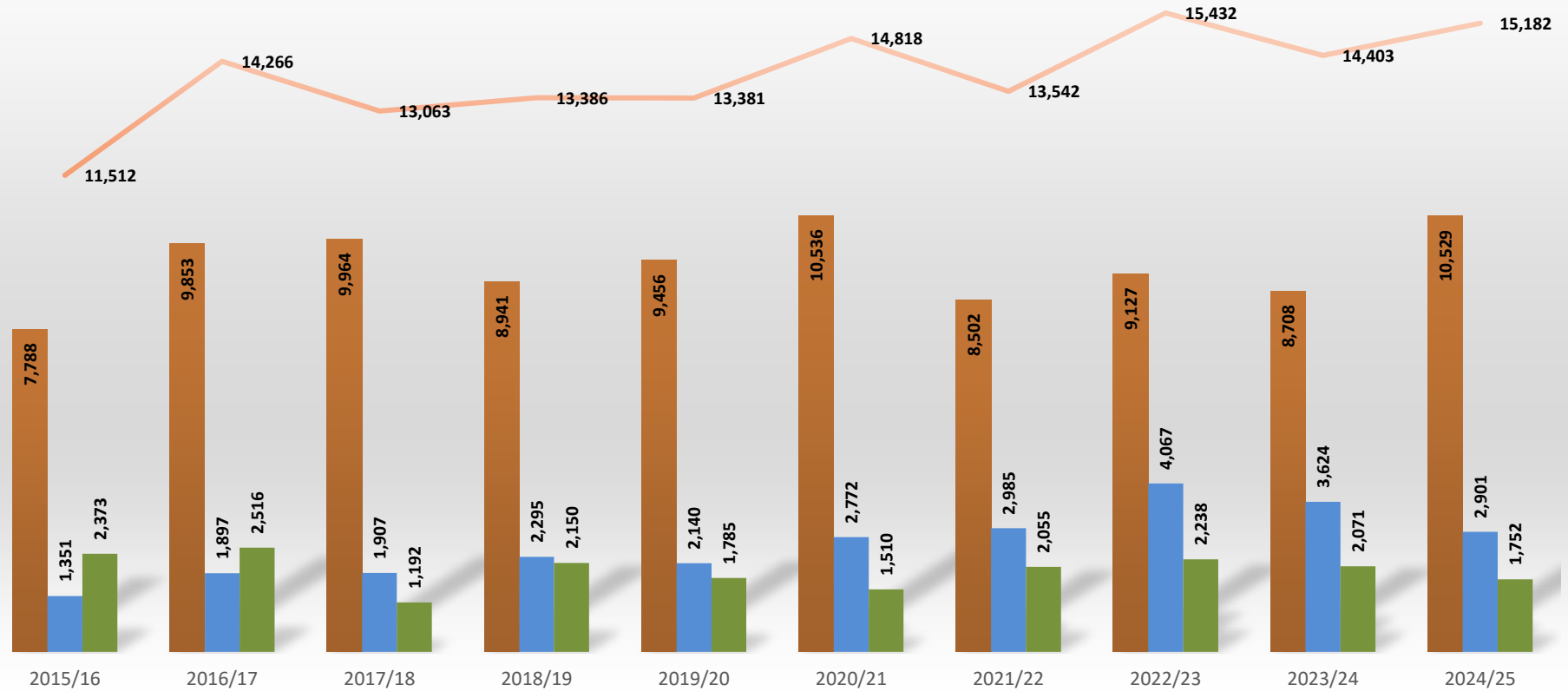

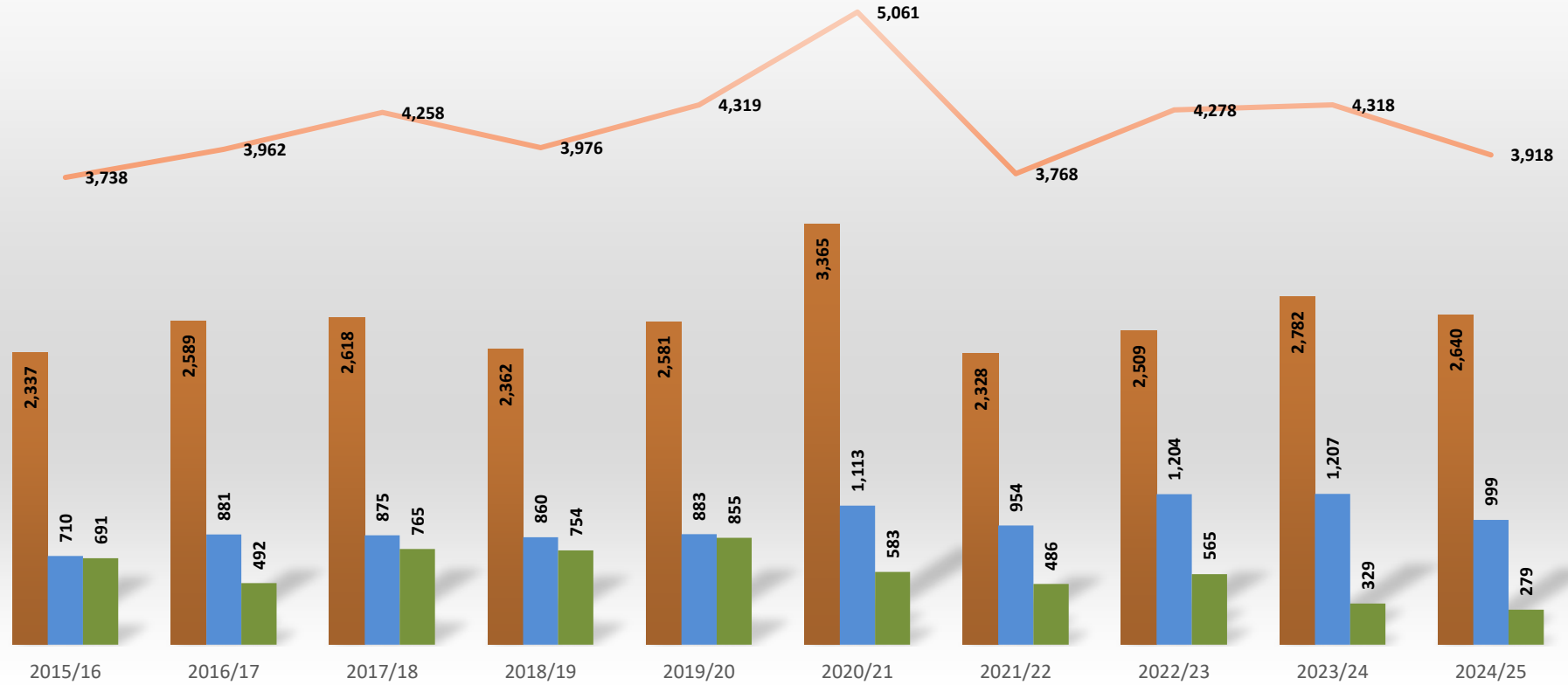

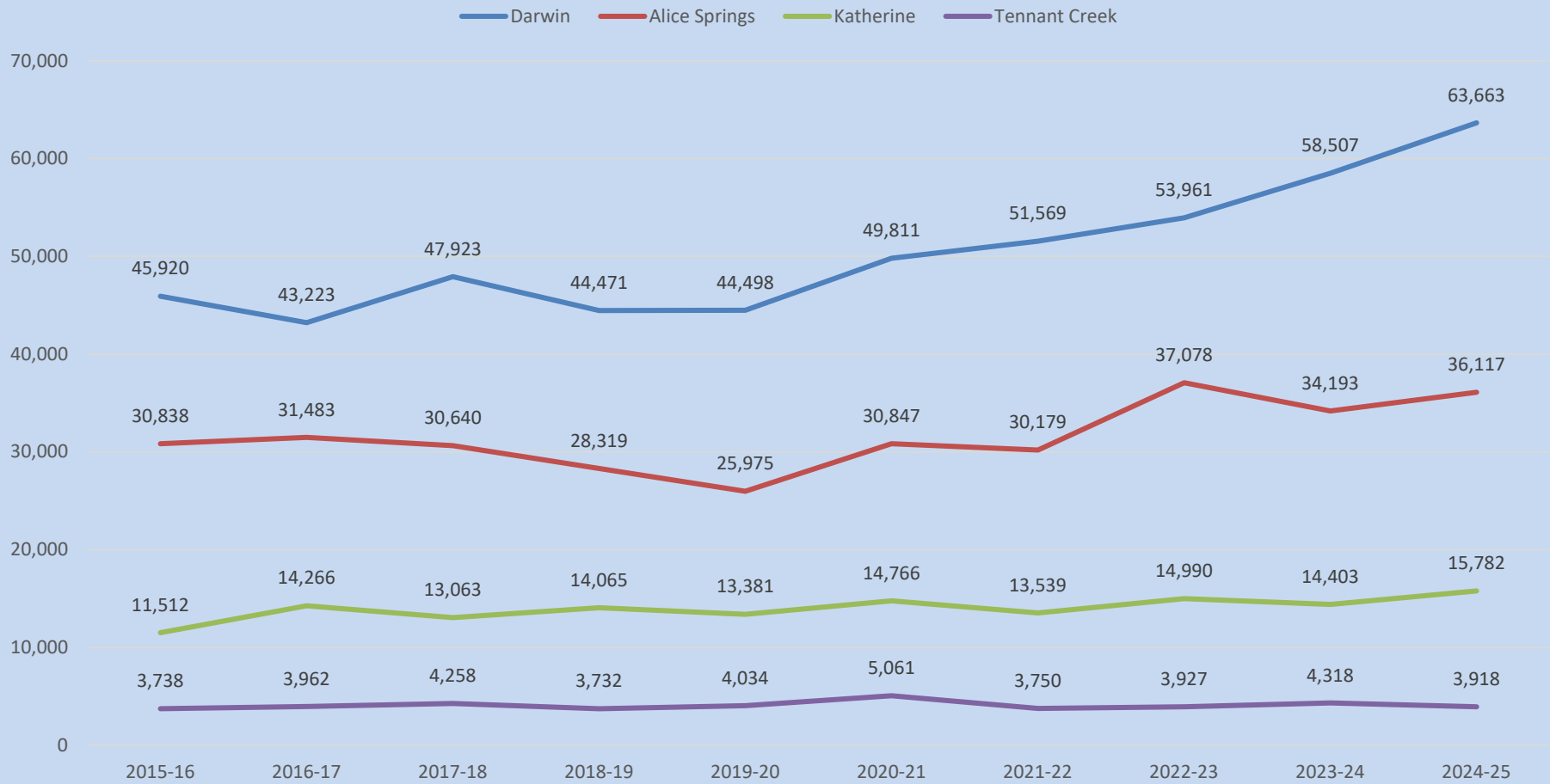

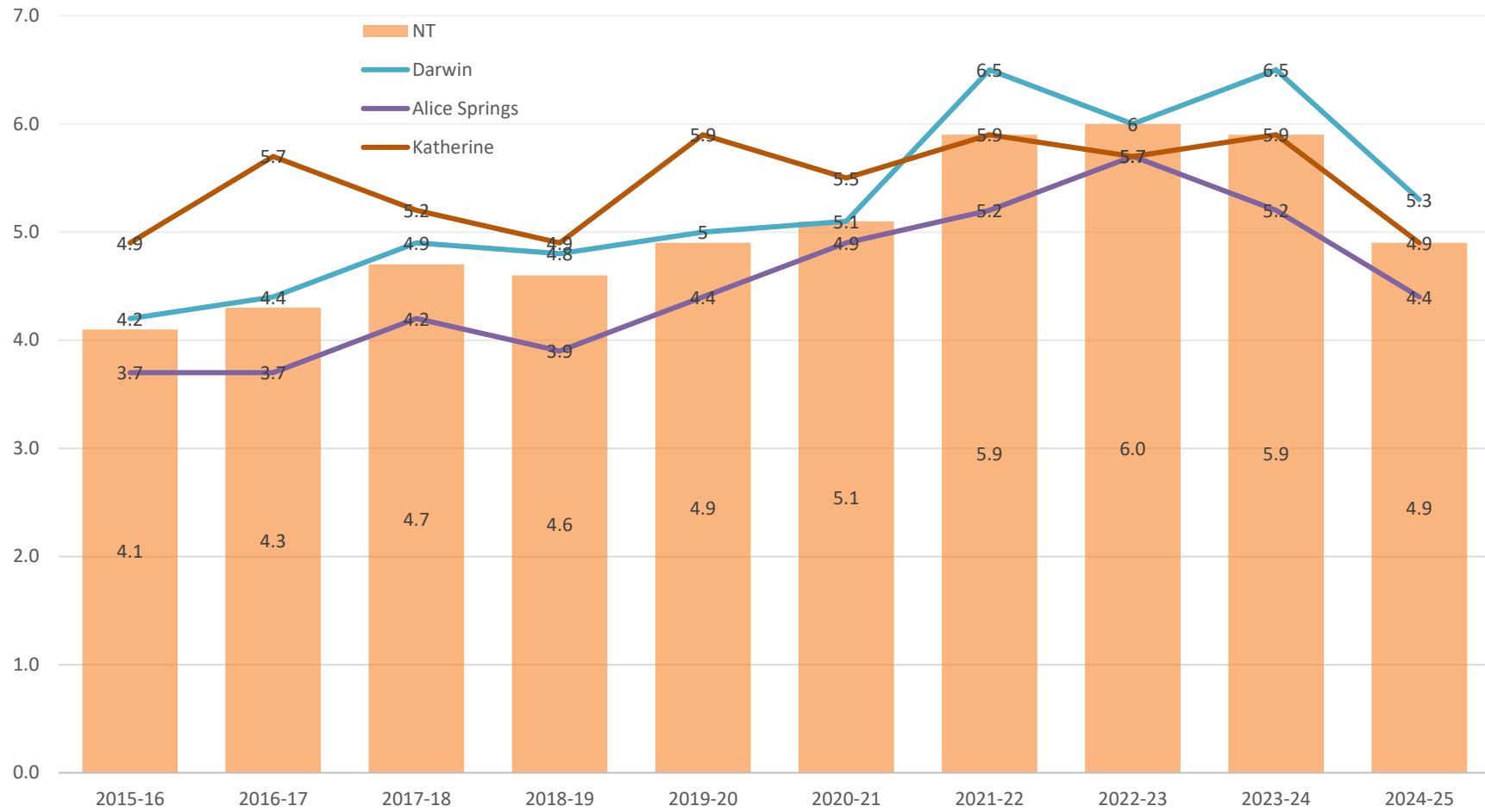

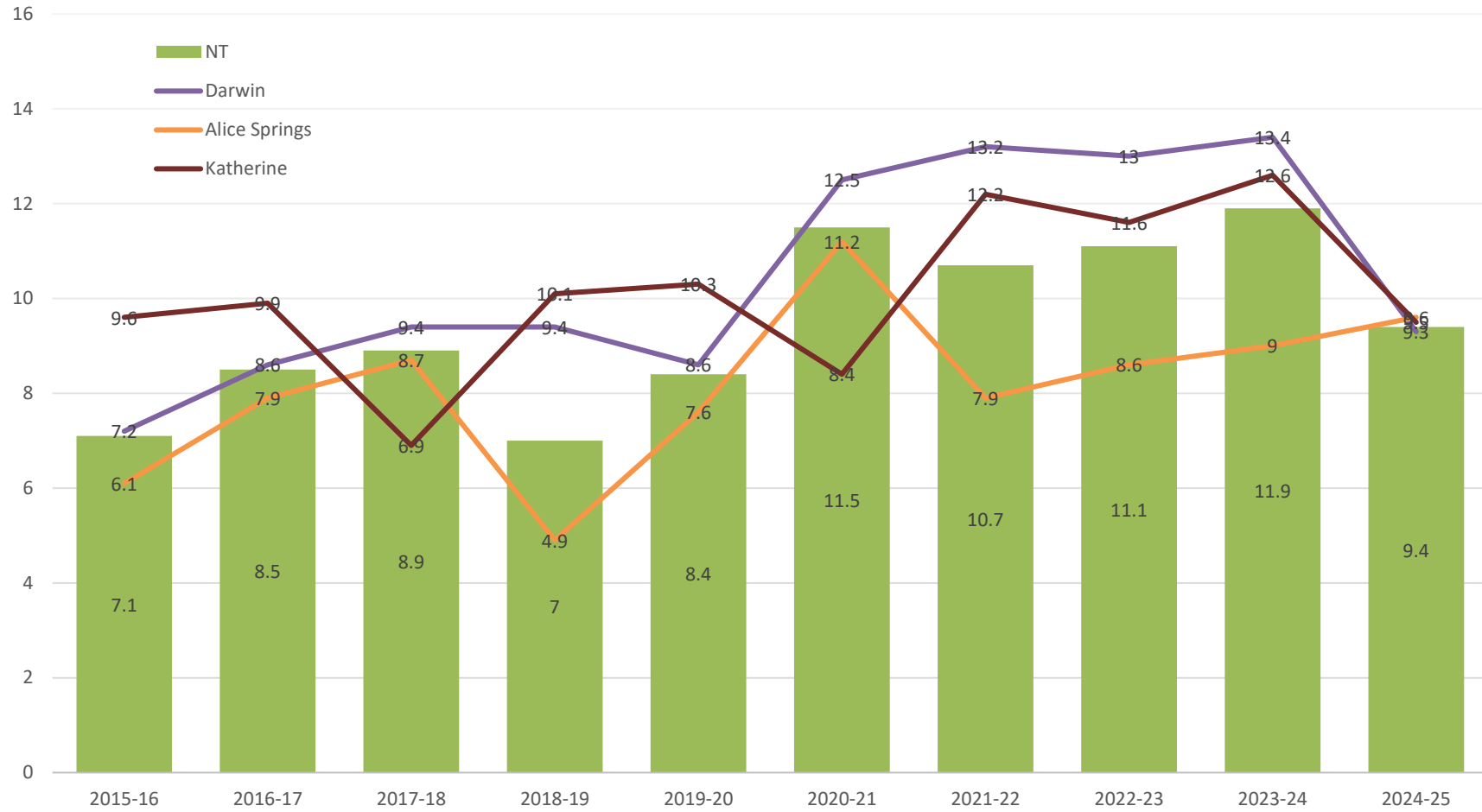
ATTENDANCE INDICATOR (LOCAL COURT)

NUMBER OF LISTINGS PER FINALISATION

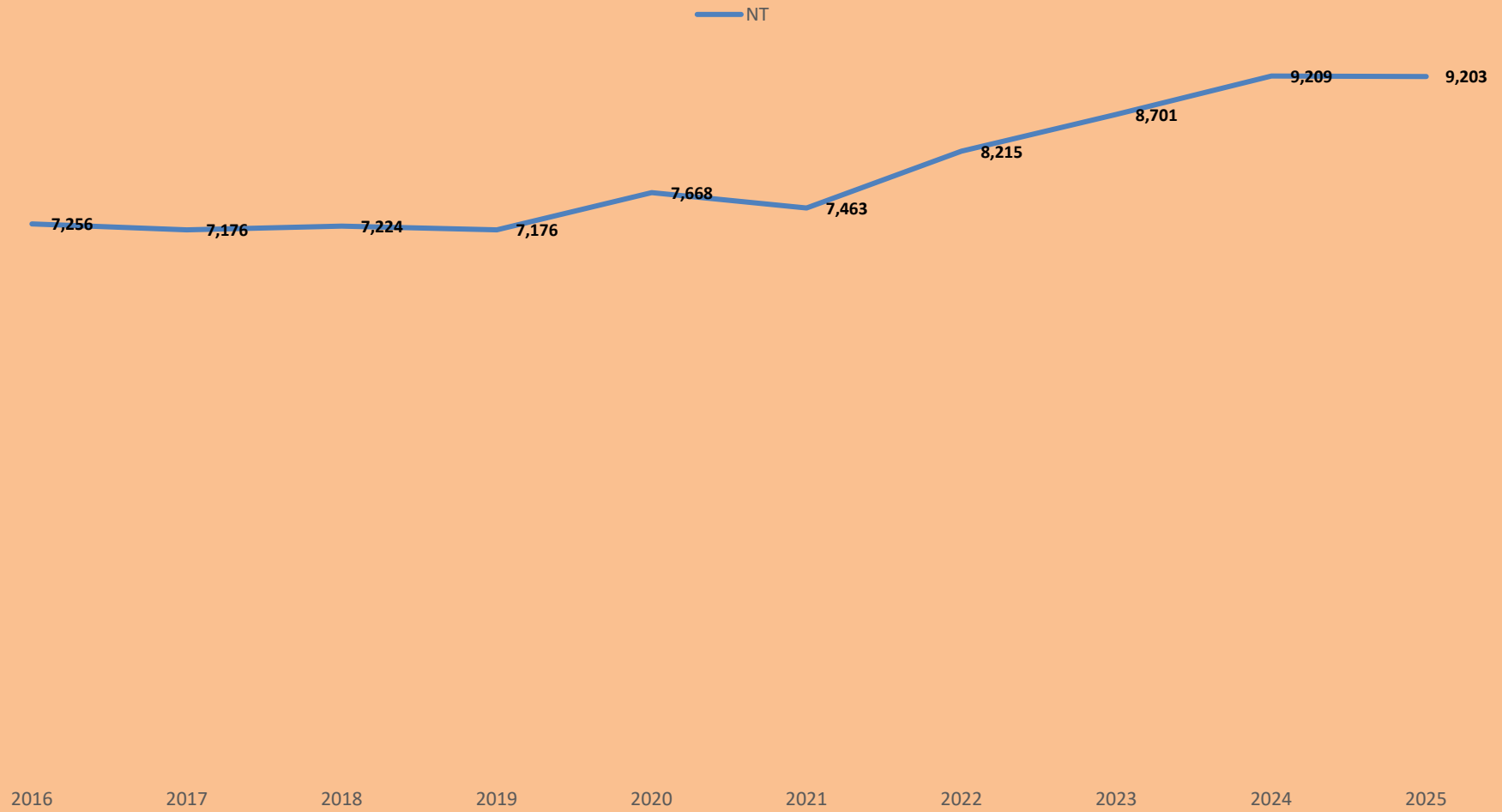


ATTENDANCE INDICATOR (YOUTH JUSTICE COURT)

LOCAL COURT (ADULTS) PENDING WORKLOAD - 2016 - JANUARY 2025



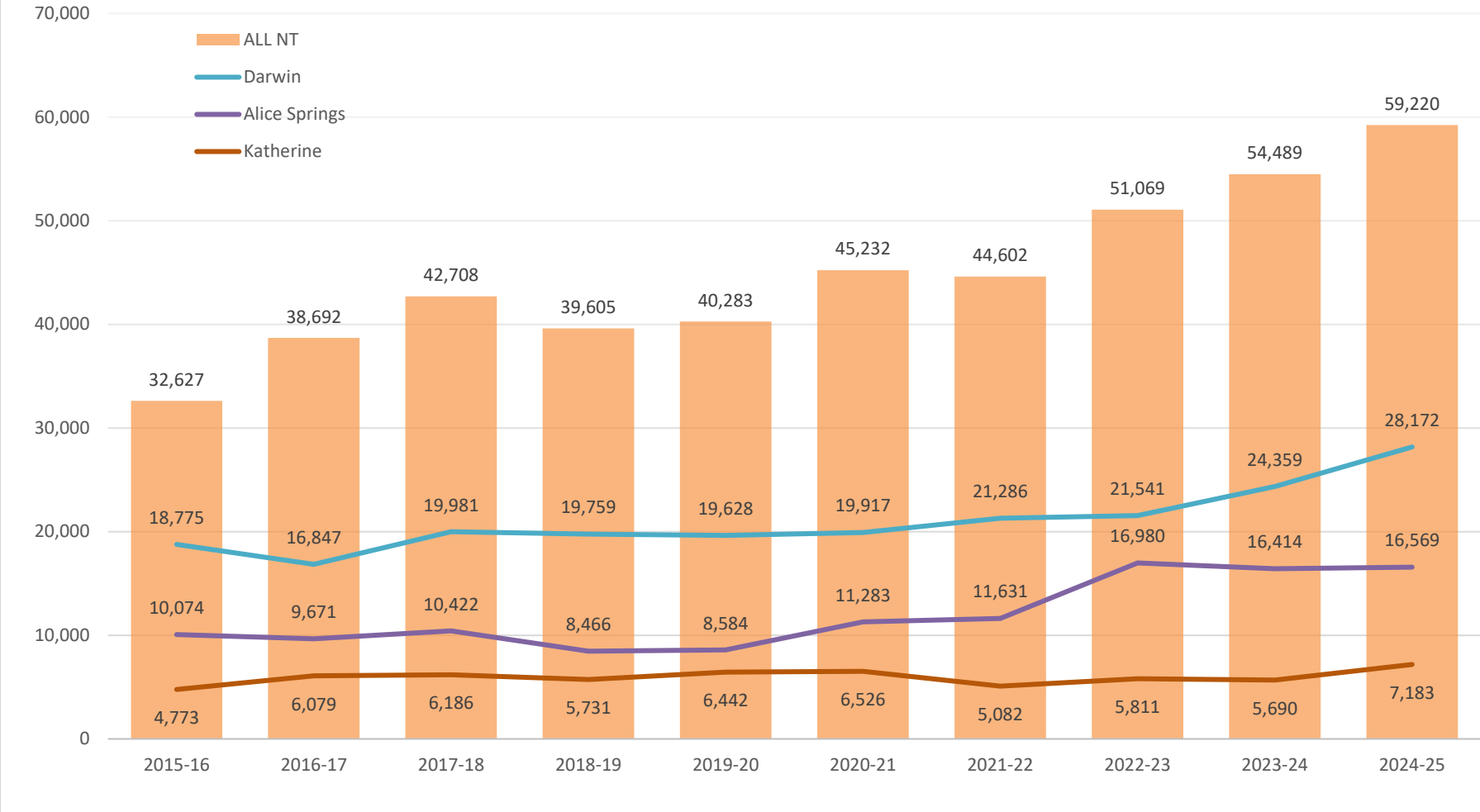

ADJOURNMENT ORDERS - LOCAL COURT CRIMINAL



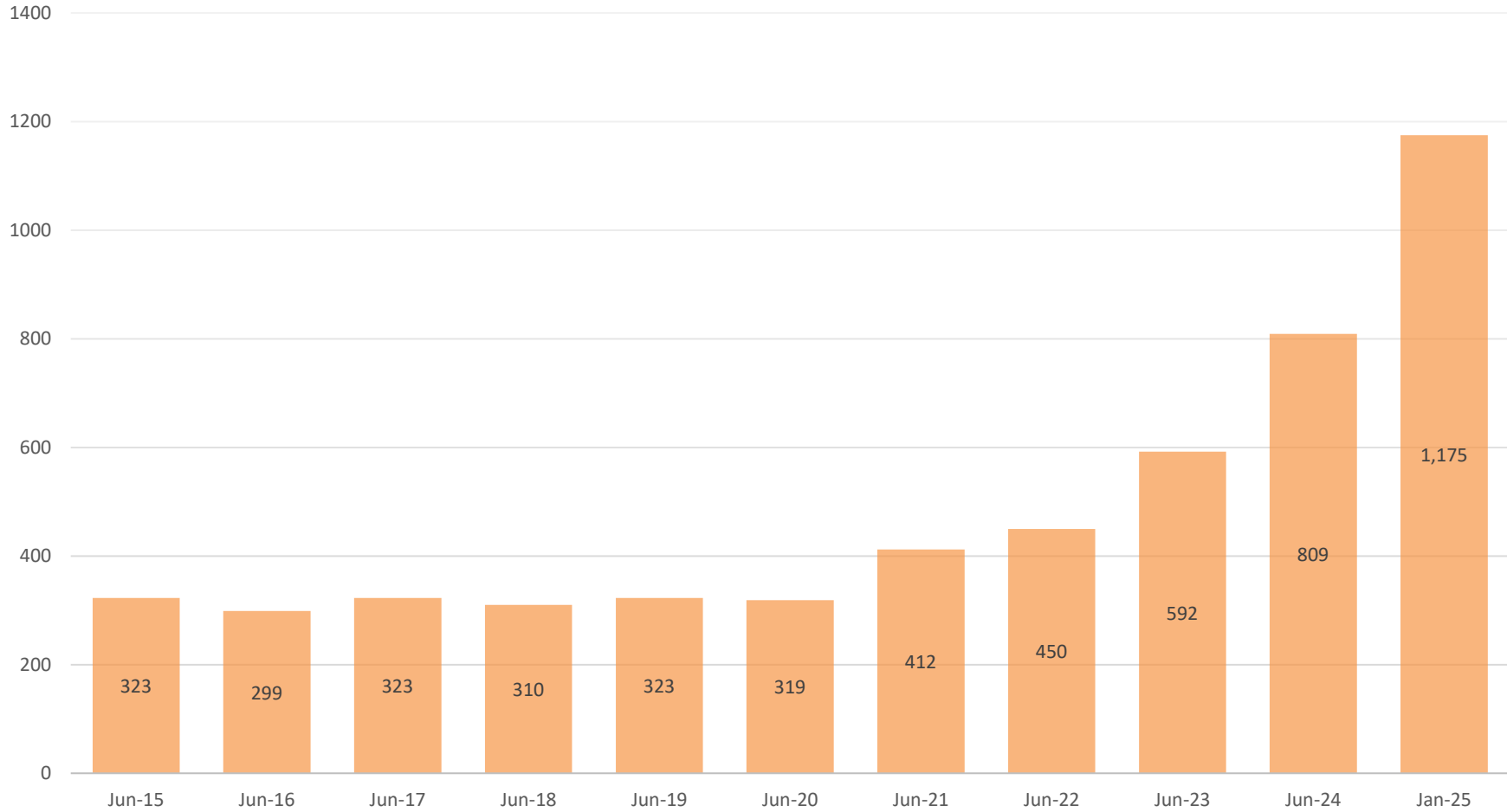

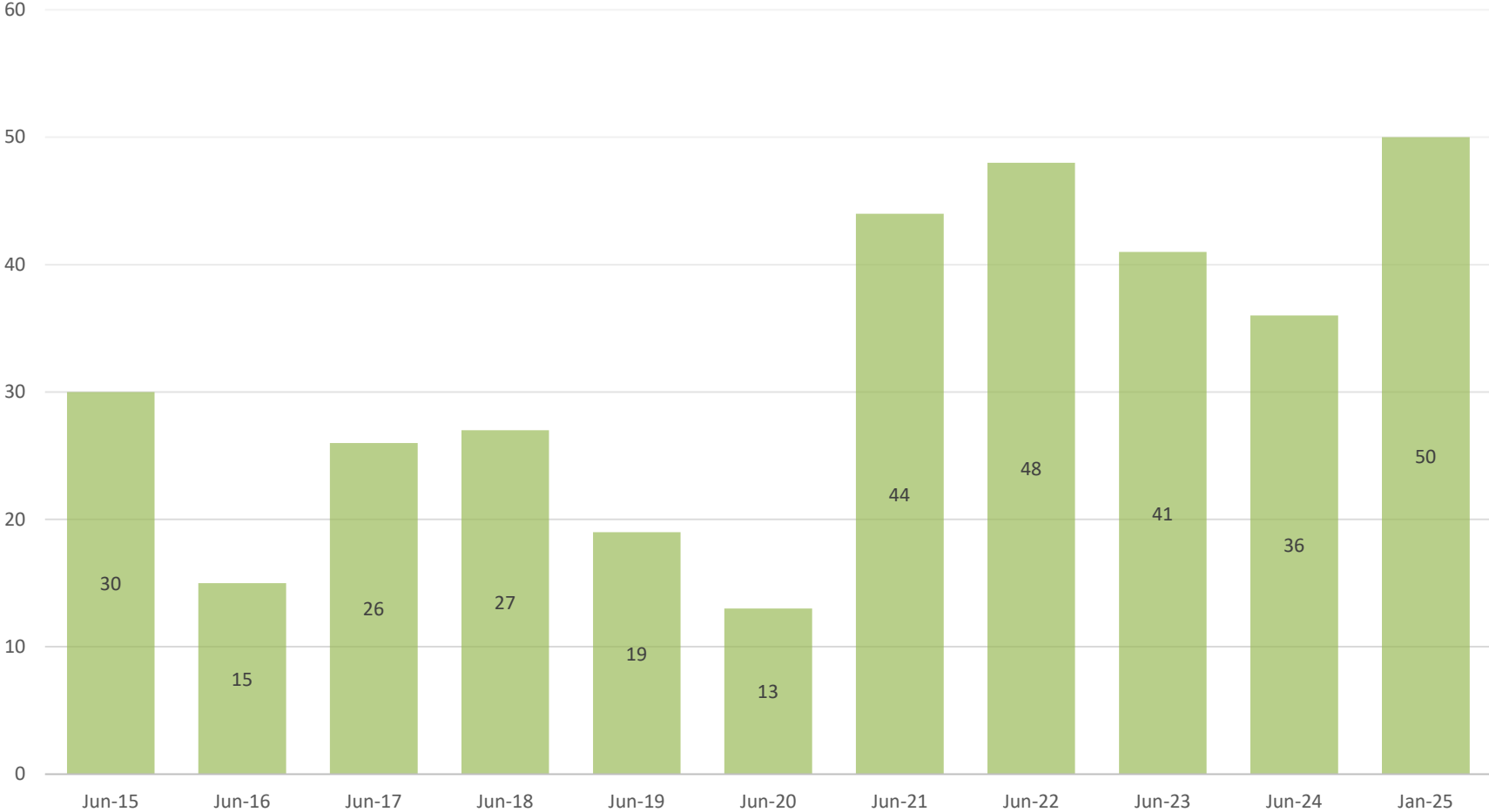

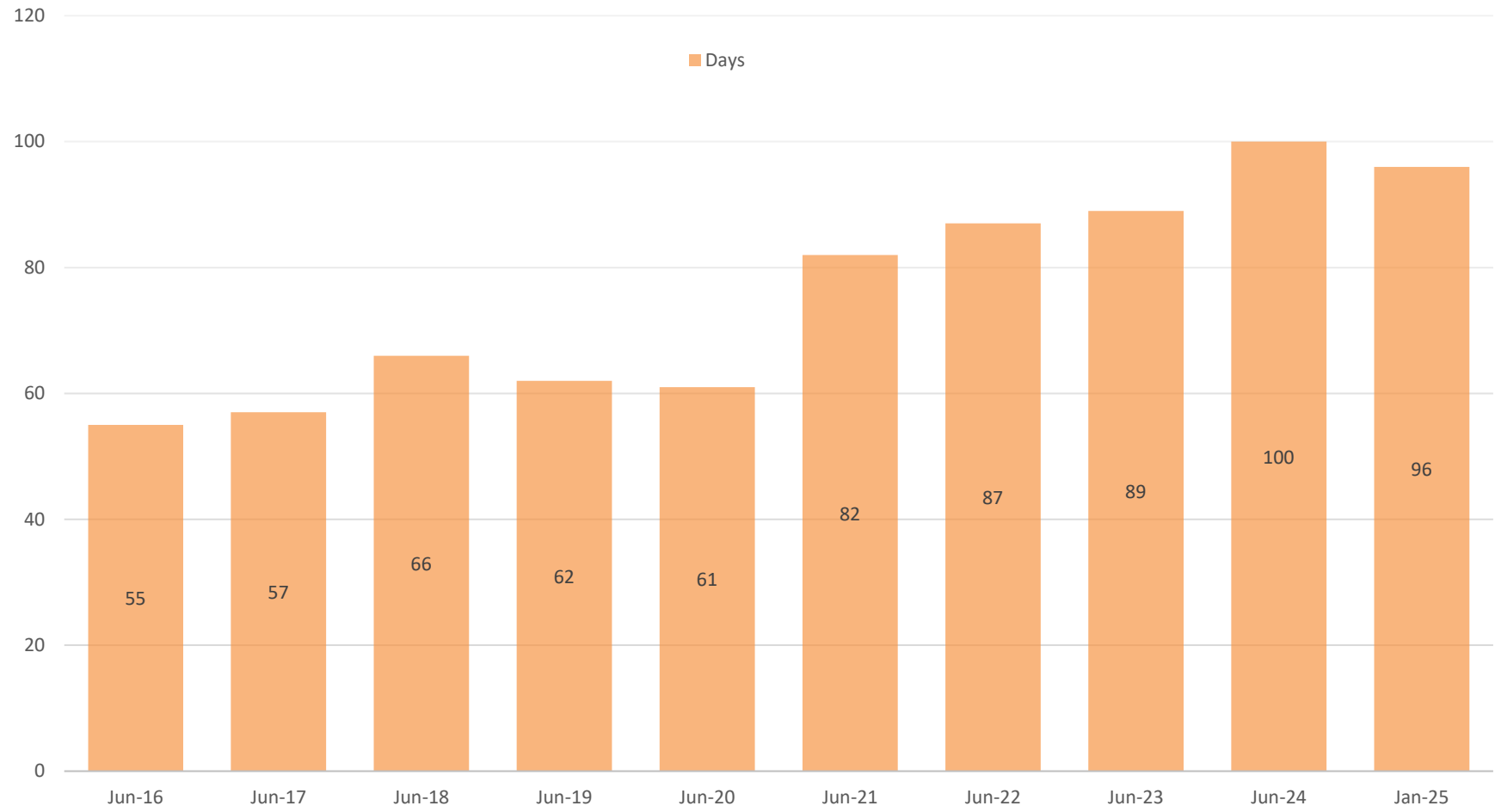
PRISONERS ON LOCAL COURT REMAND



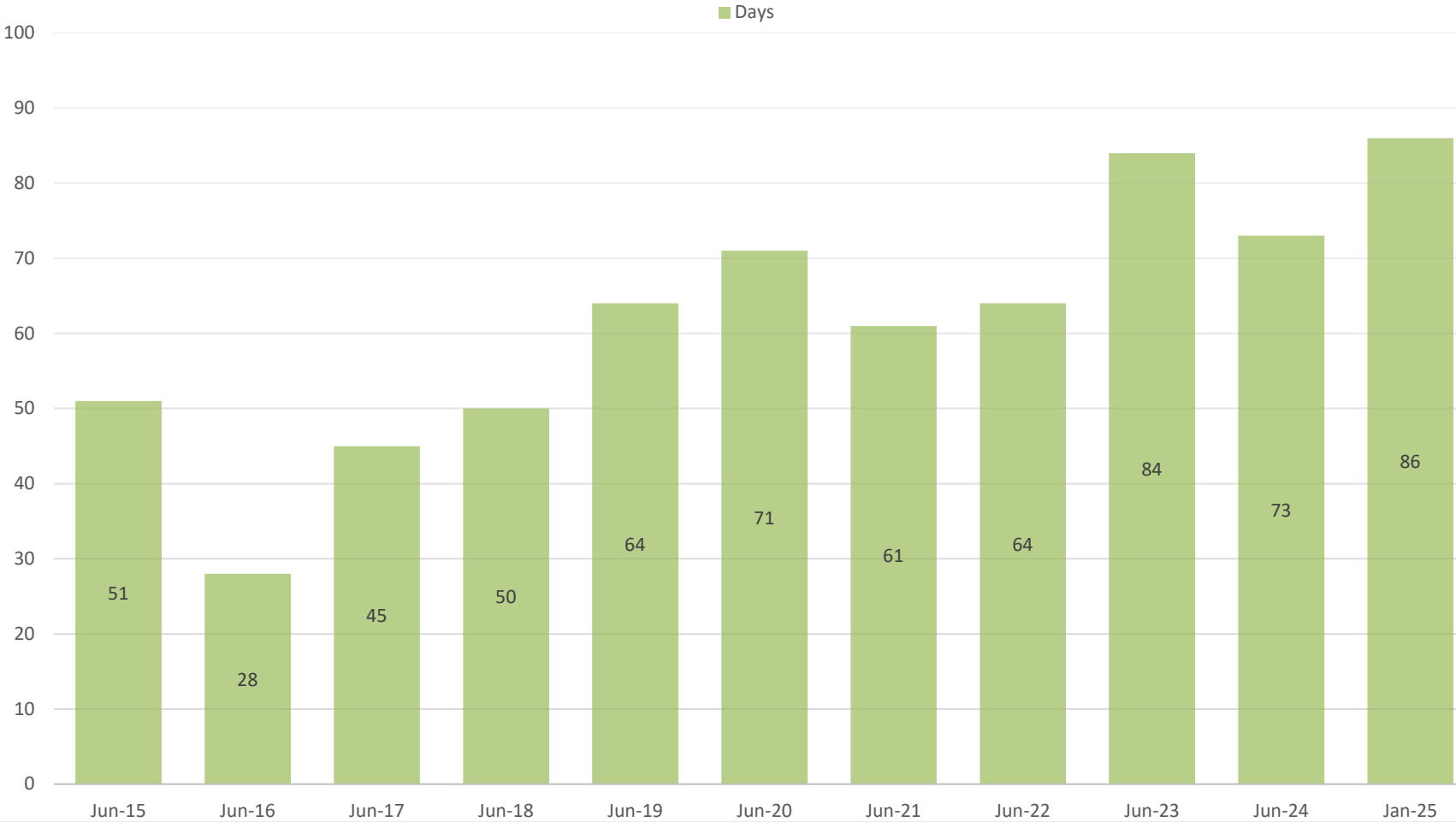
DETAINEES ON YOUTH COURT REMAND



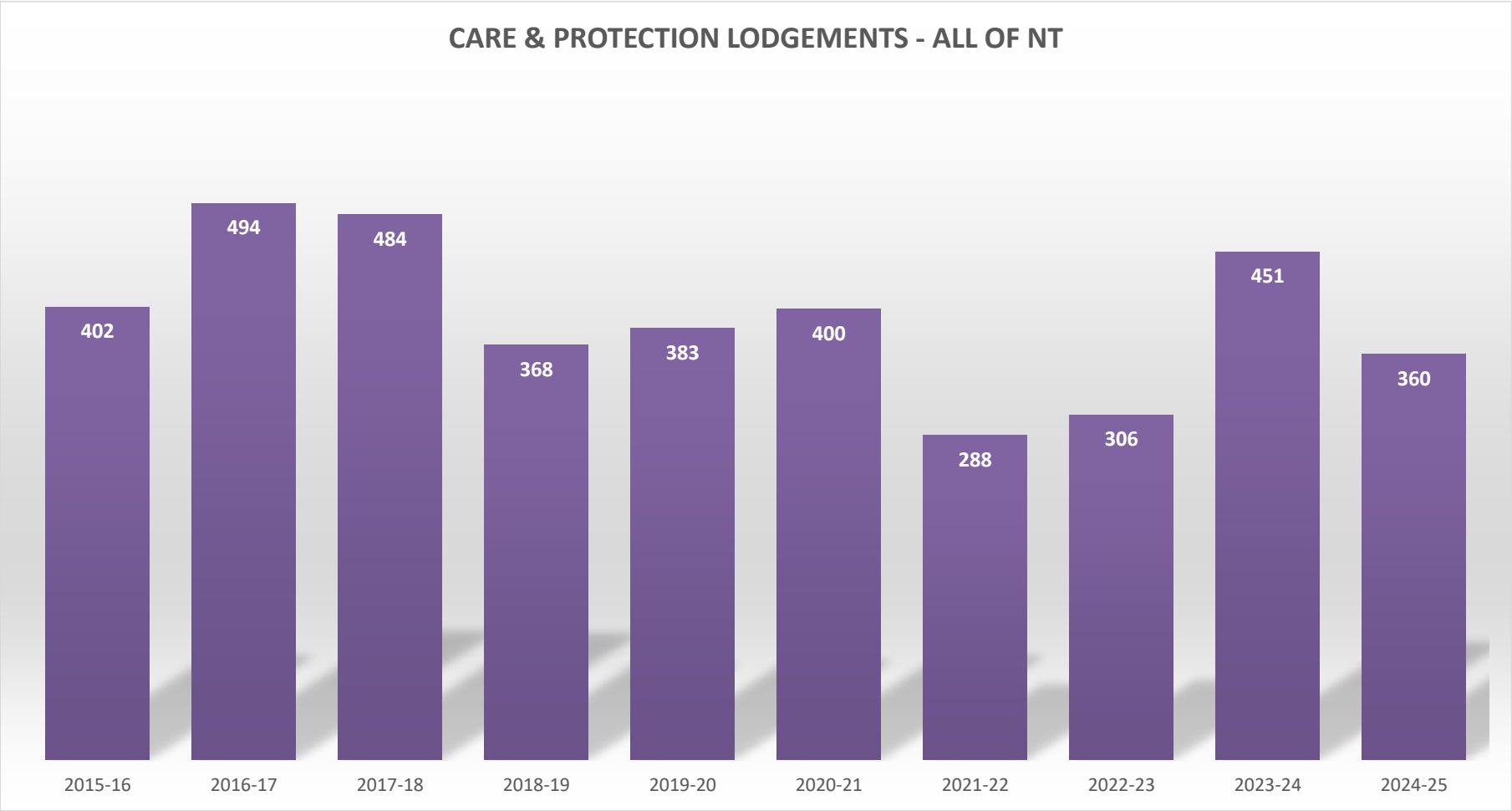
AVERAGE REMAND TIME FOR LOCAL COURT



AVERAGE REMAND TIME FOR YOUTH COURT



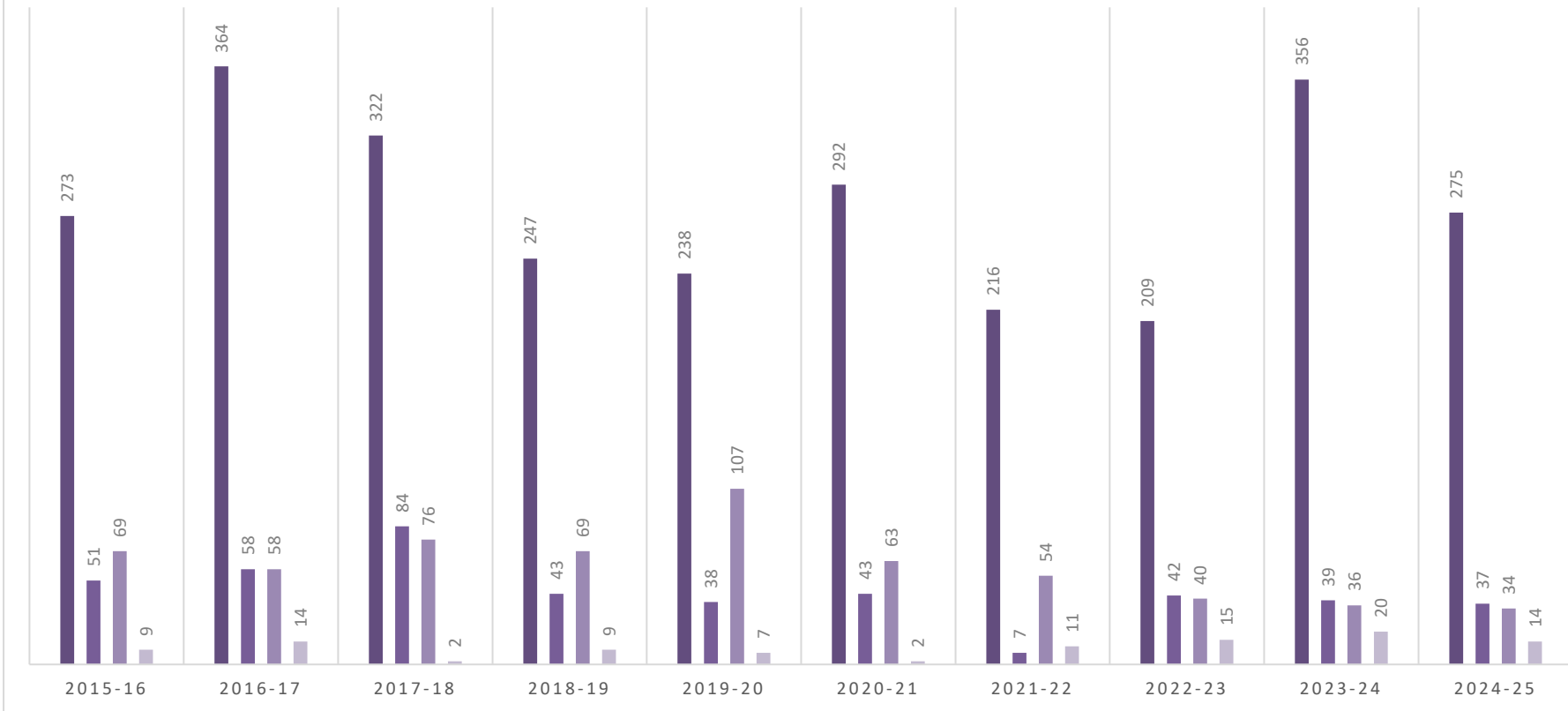

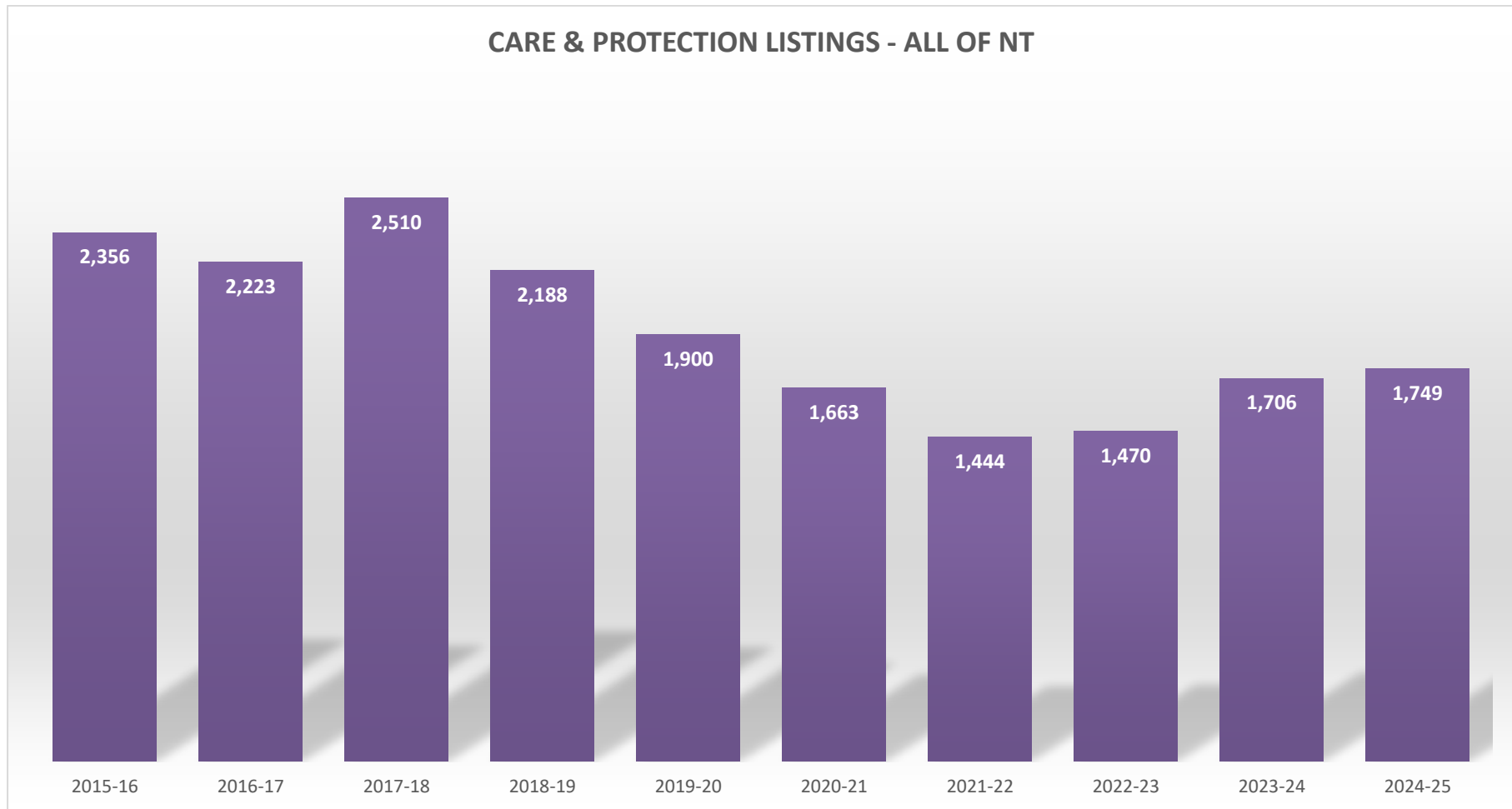

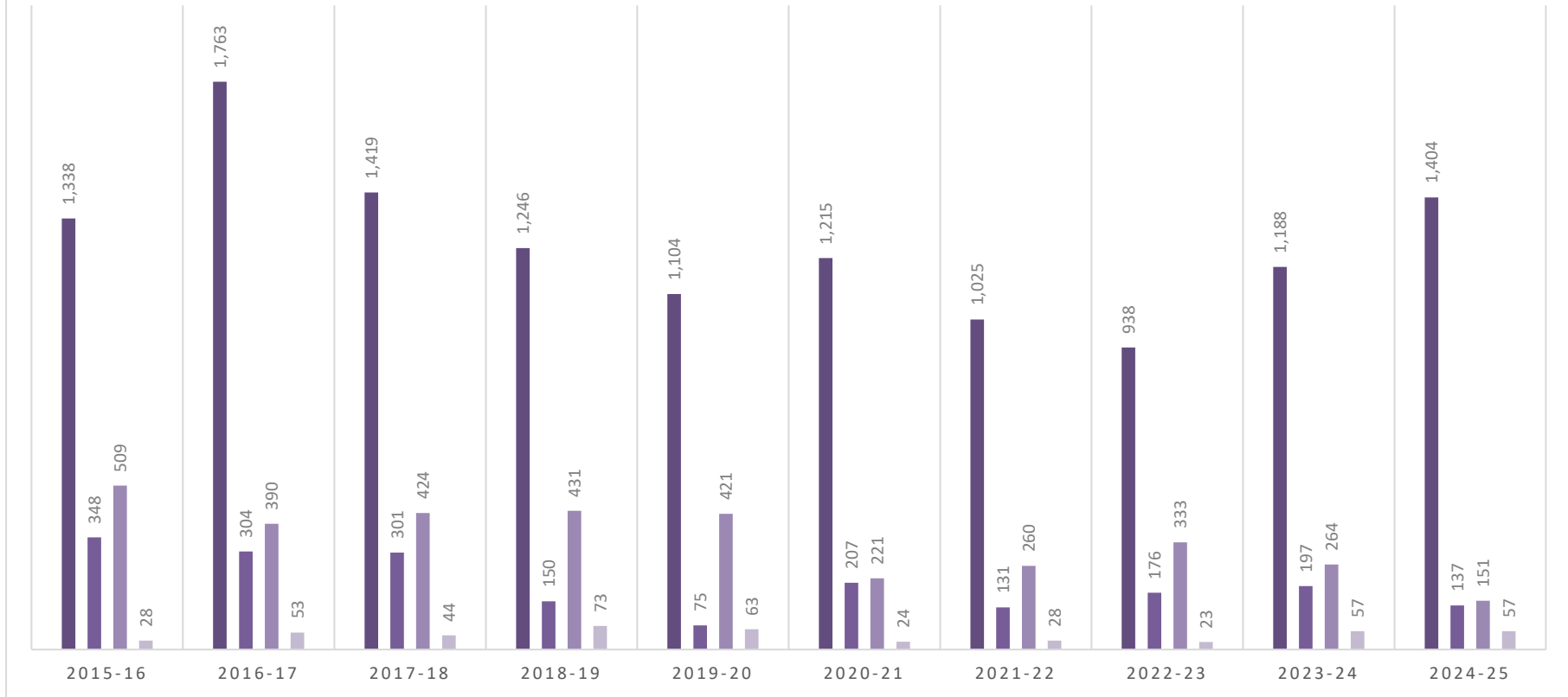
