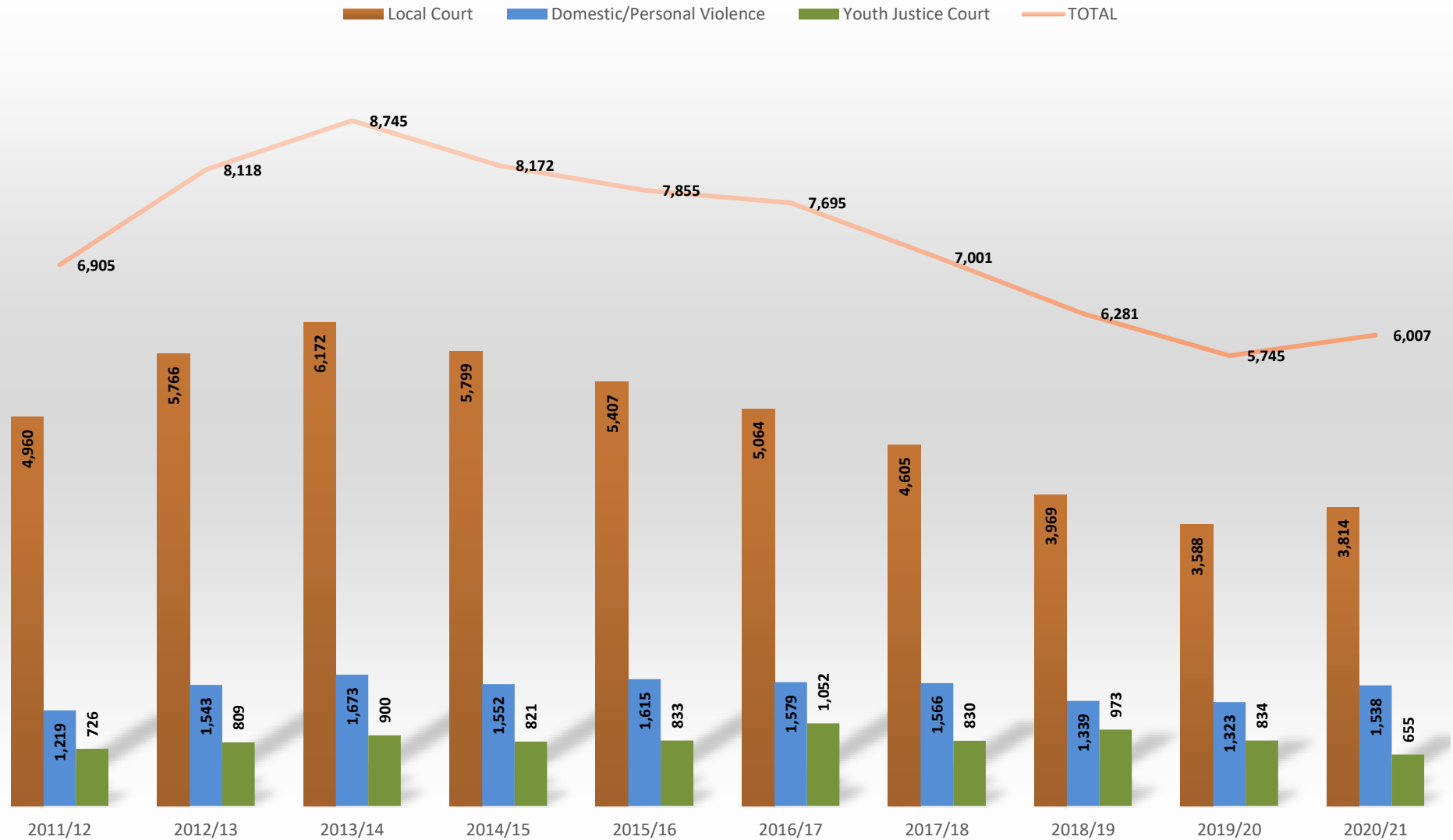

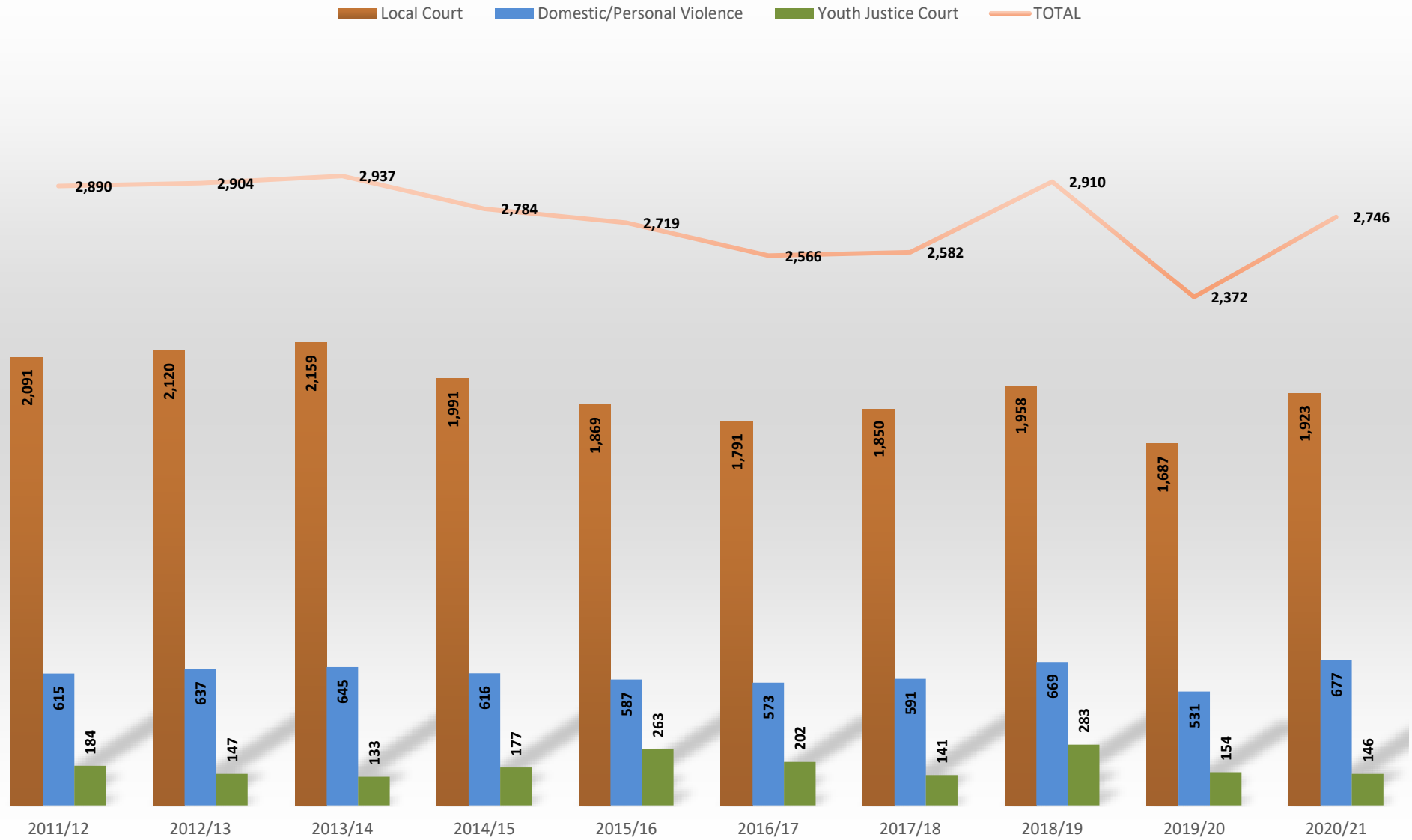
CRIMINAL & DOMESTIC/PERSONAL VIOLENCE LODGEMENTS - DARWIN REGION



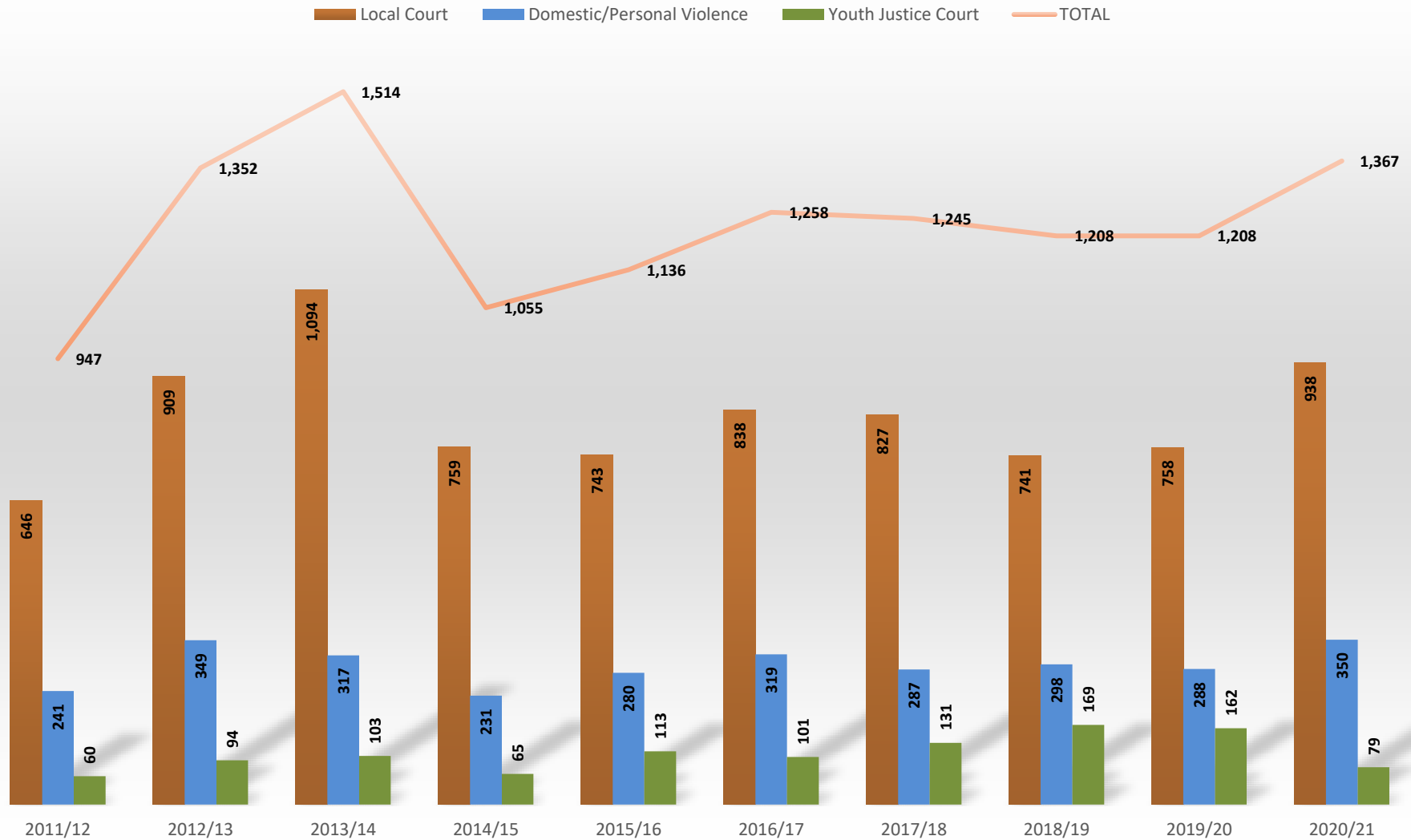
CRIMINAL & DOMESTIC/PERSONAL VIOLENCE LODGEMENTS - ALICE SPRINGS/BARKLY REGION



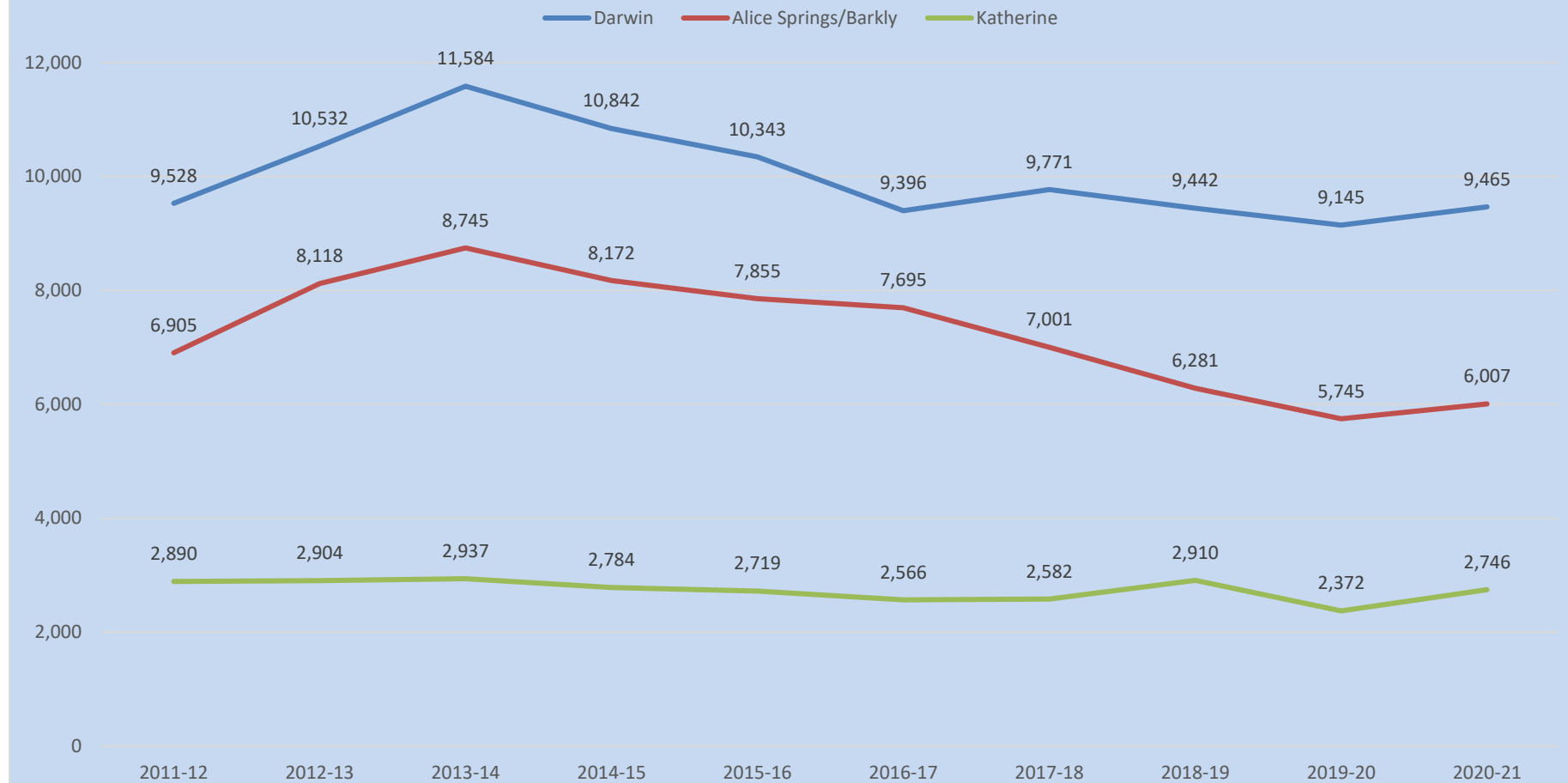

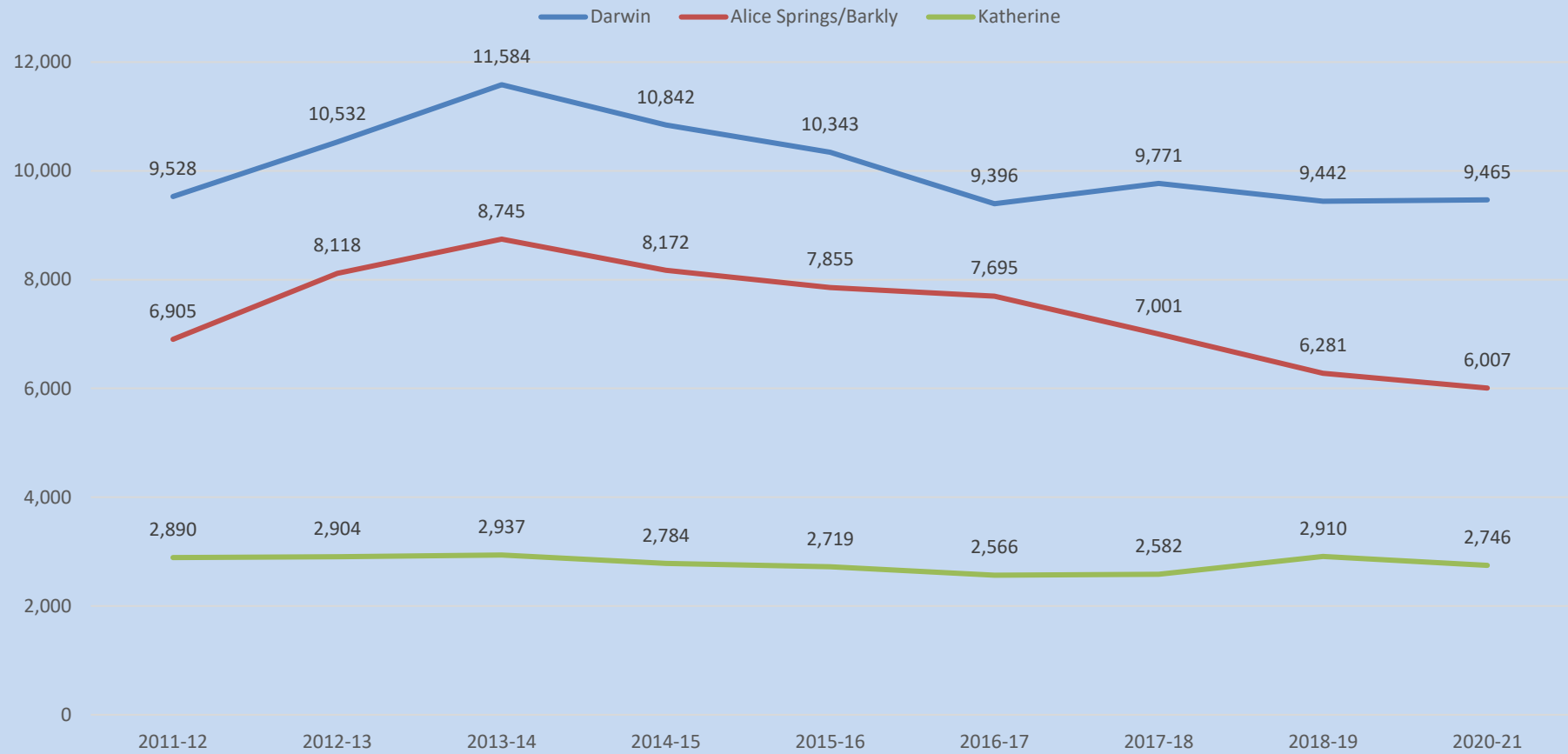

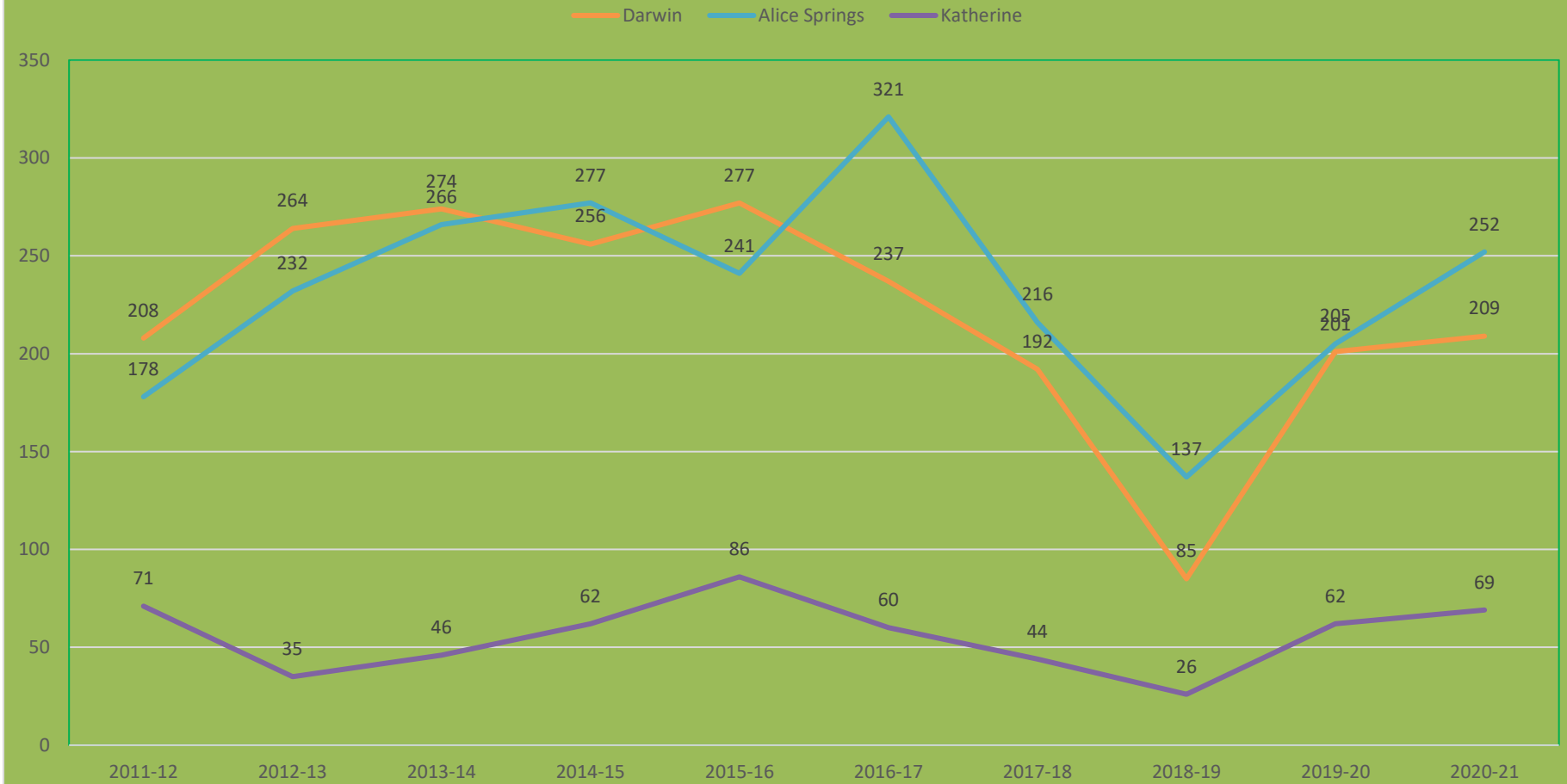

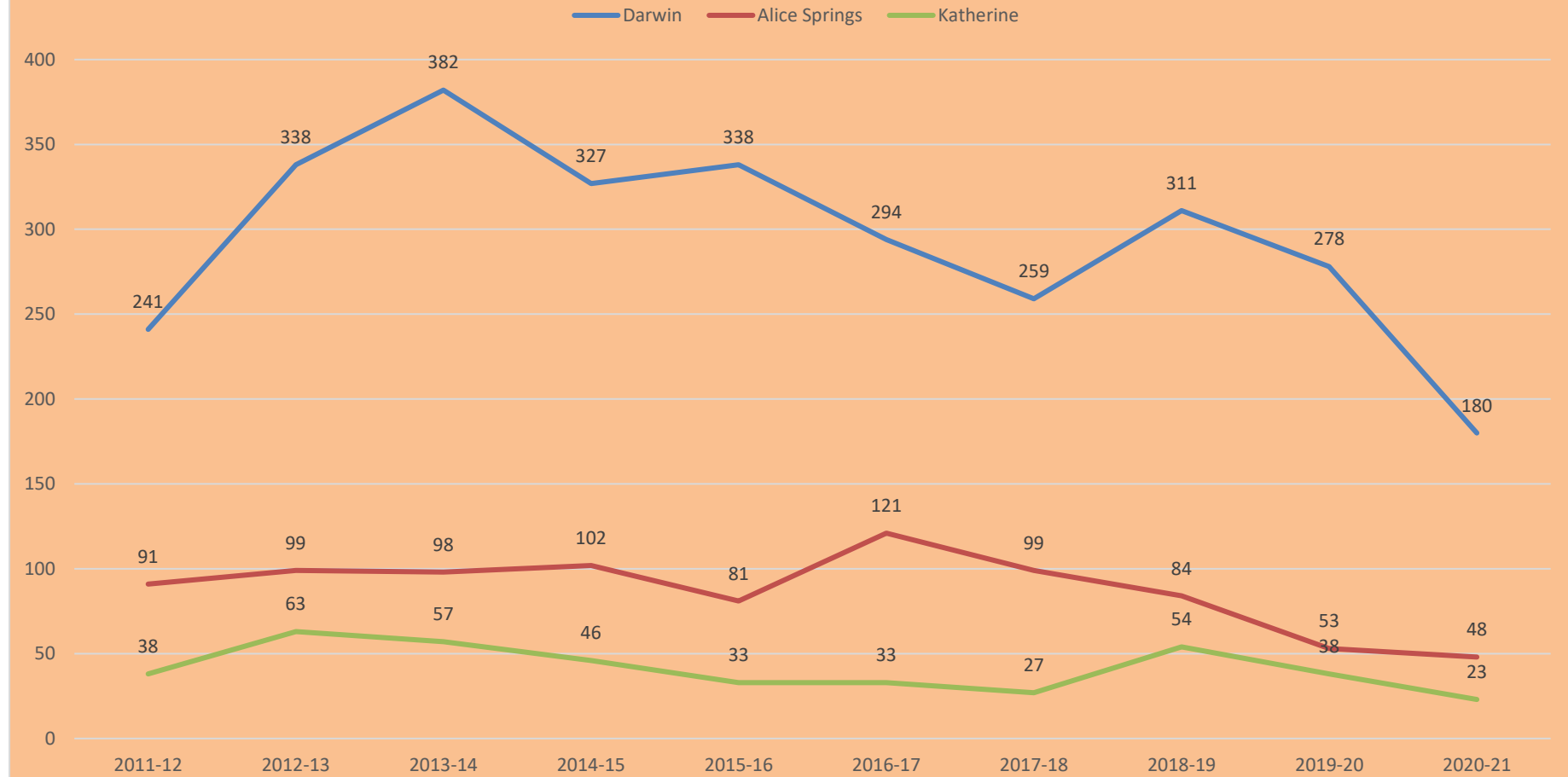




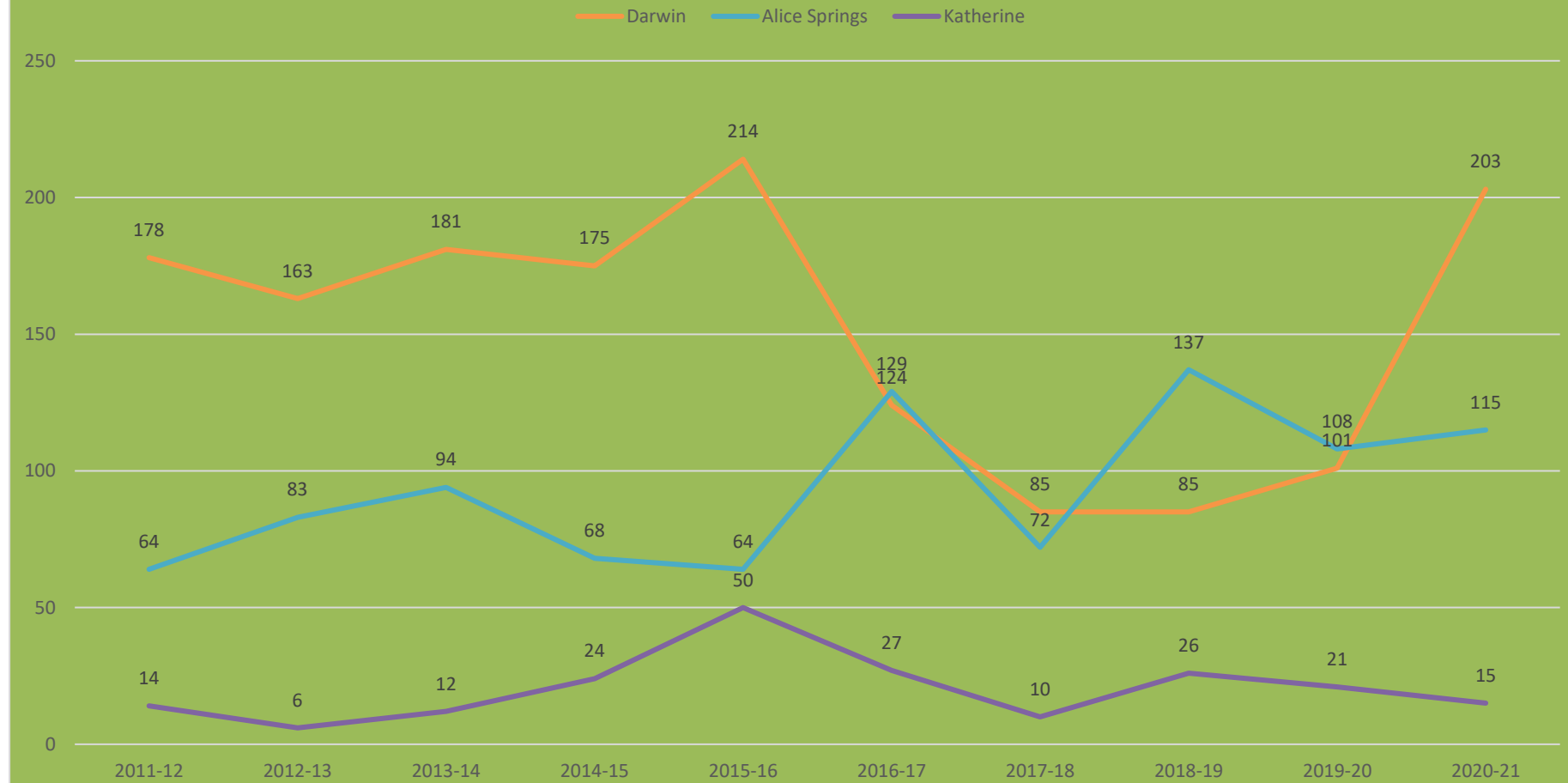
YOUTH JUSTICE COURT LODGEMENTS - UNLAWFUL ENTRY

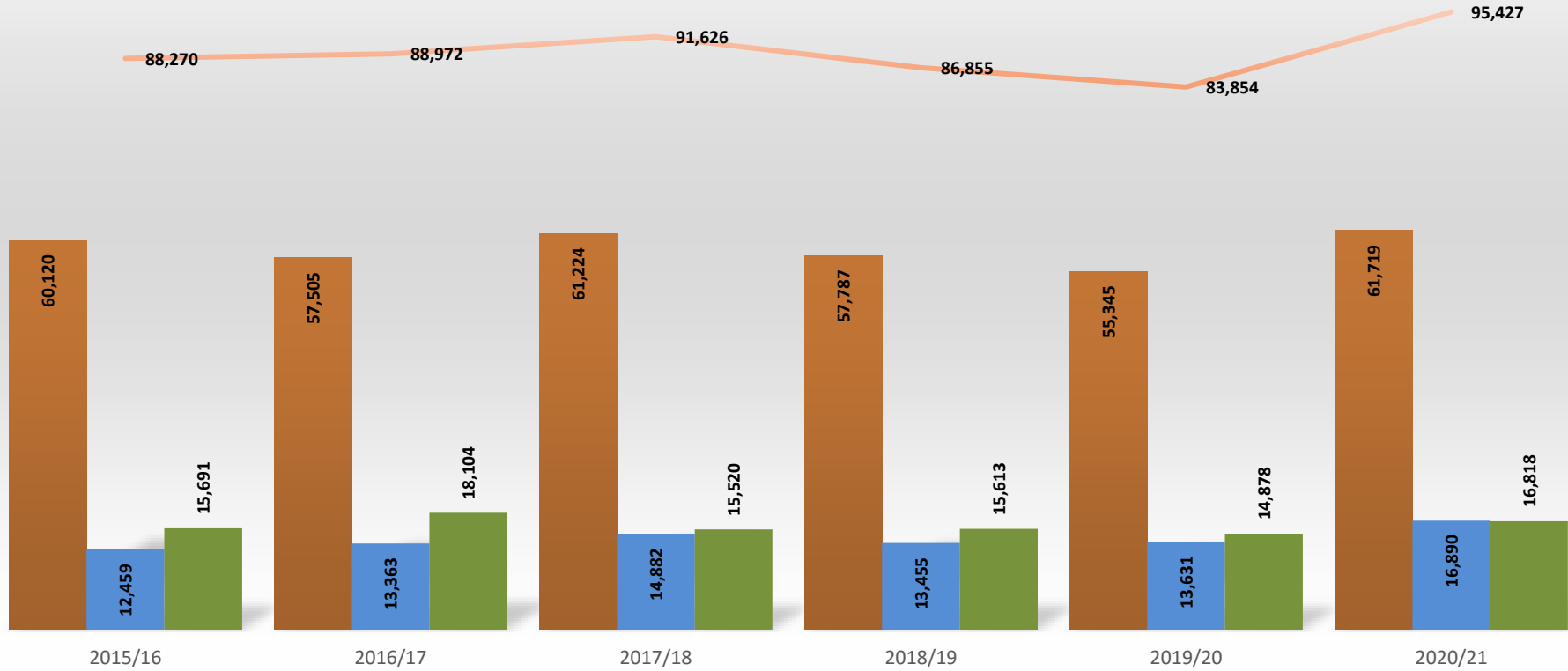

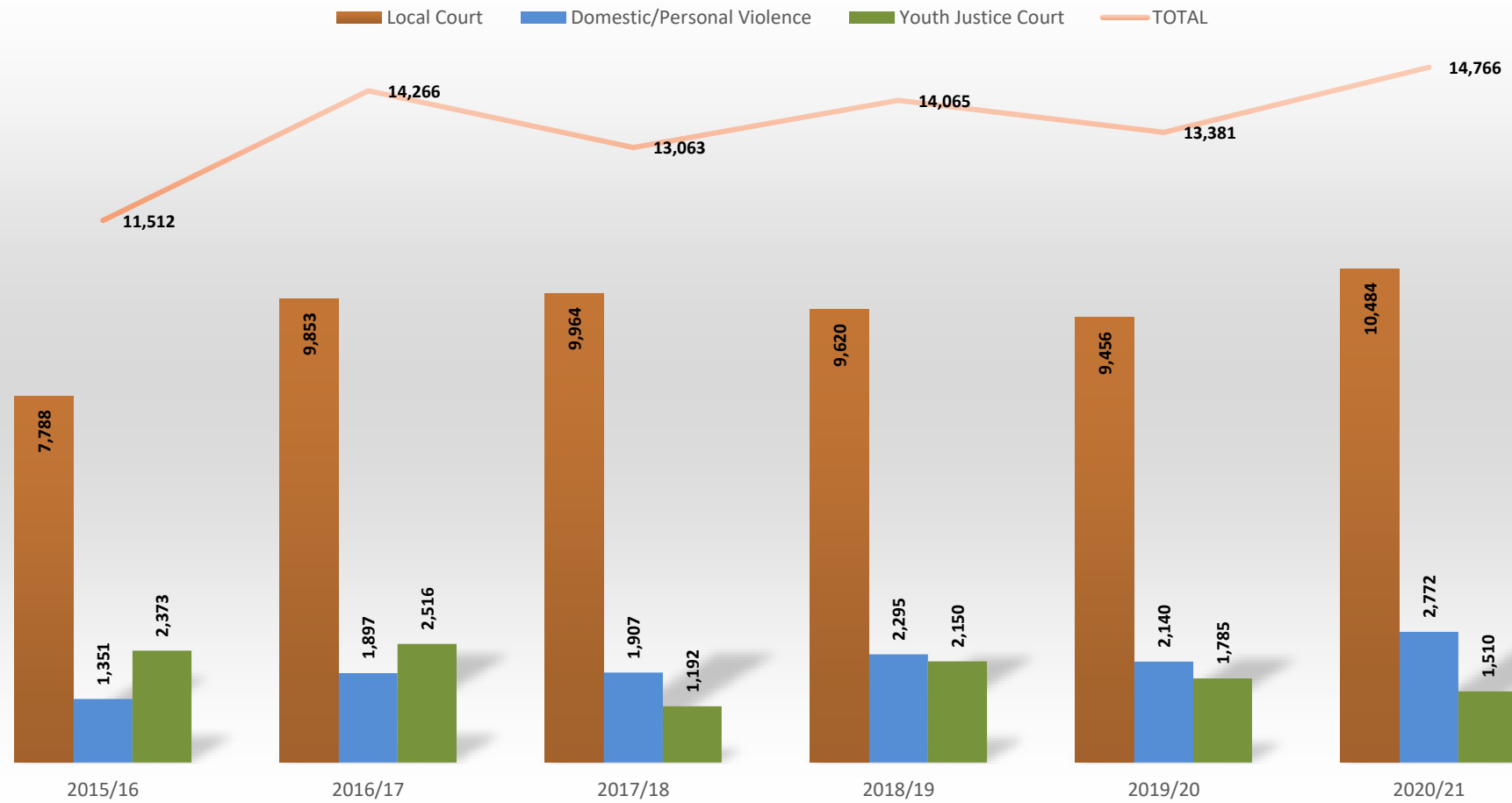

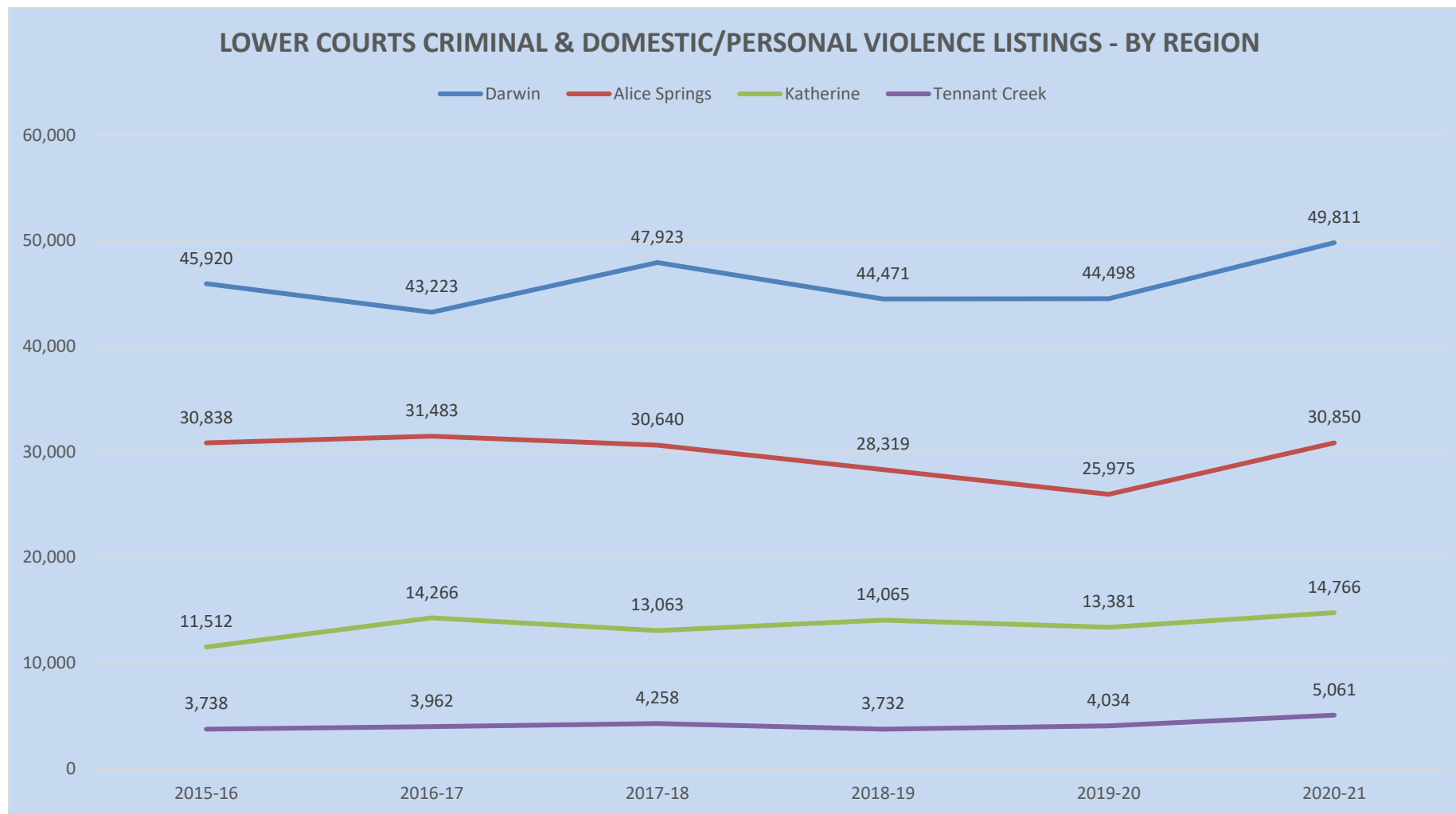


CRIMINAL & DOMESTIC/PERSONAL VIOLENCE LISTINGS - KATHERINE REGION

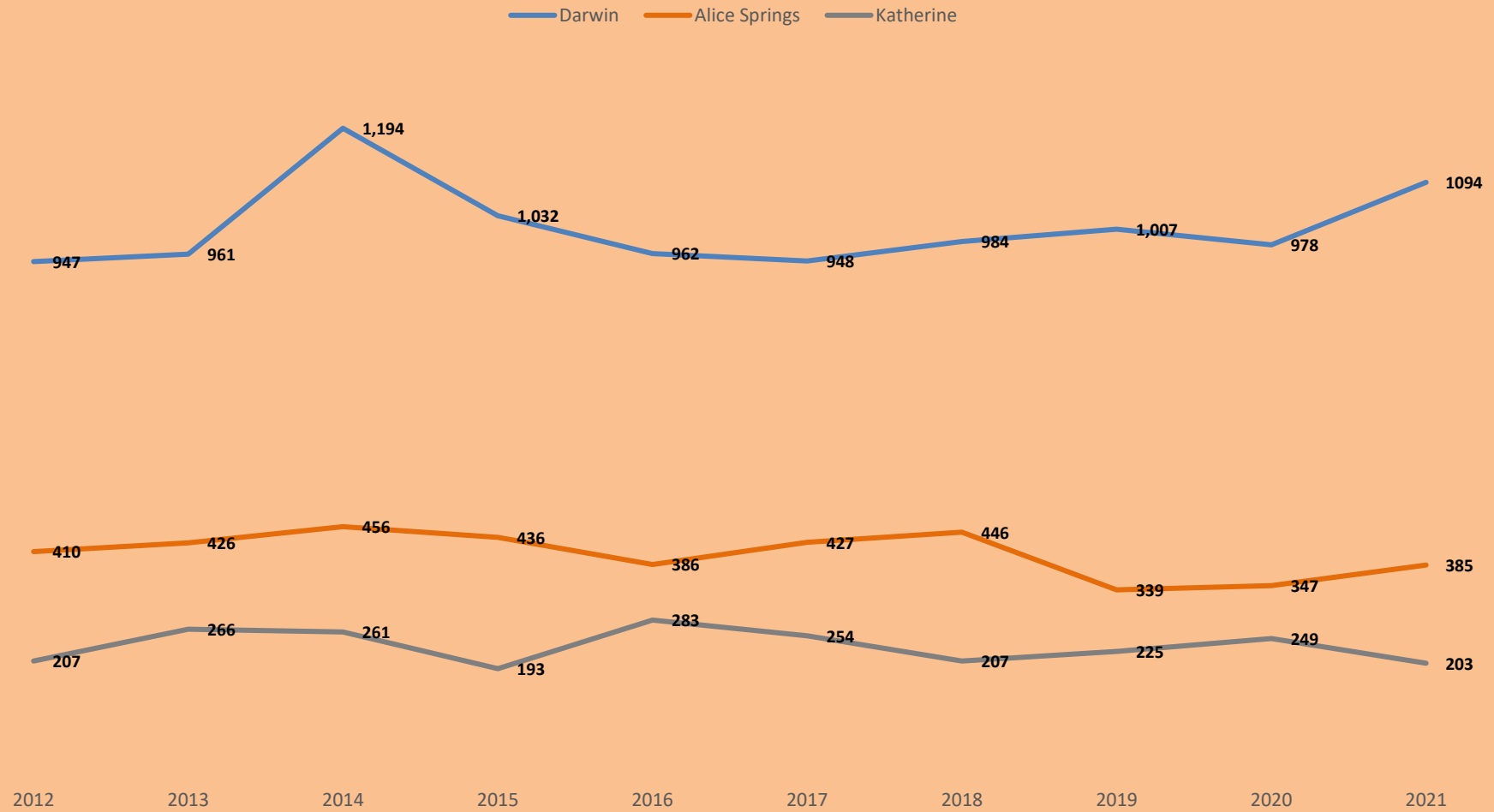

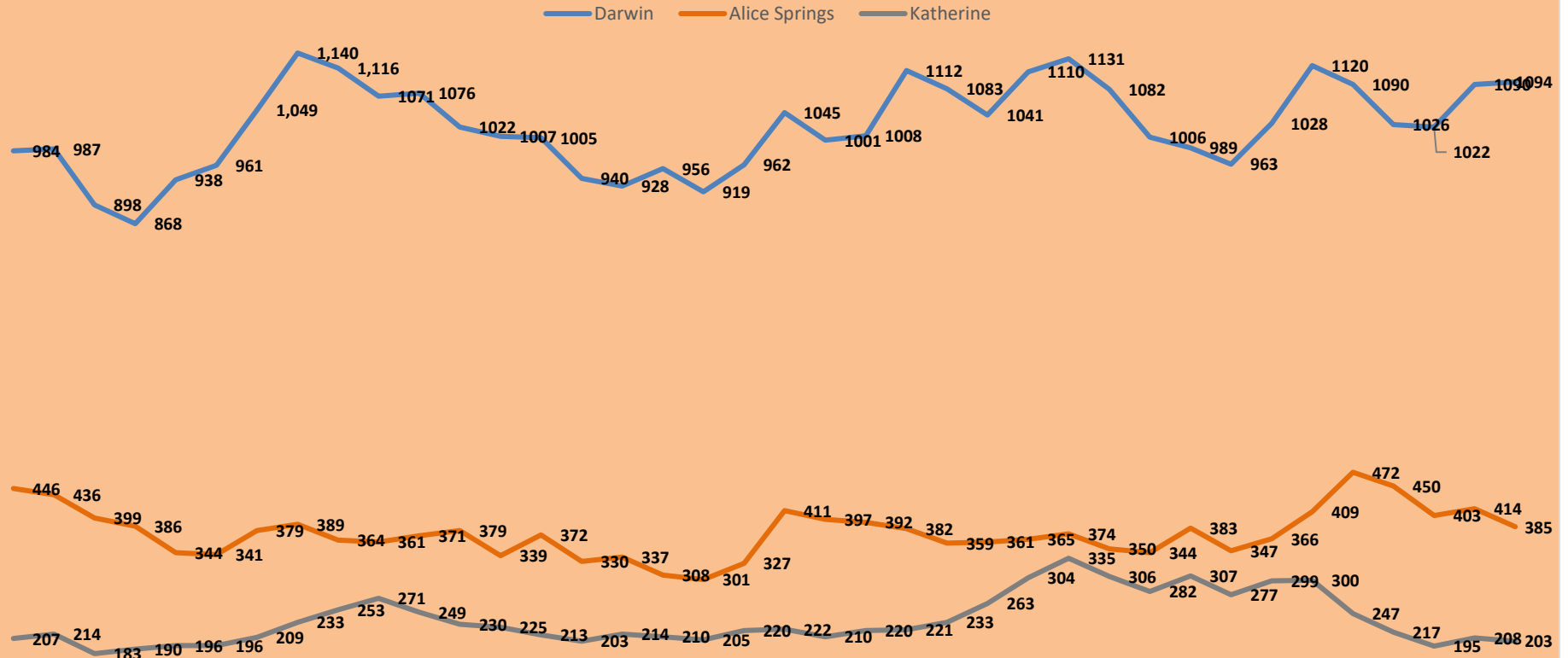

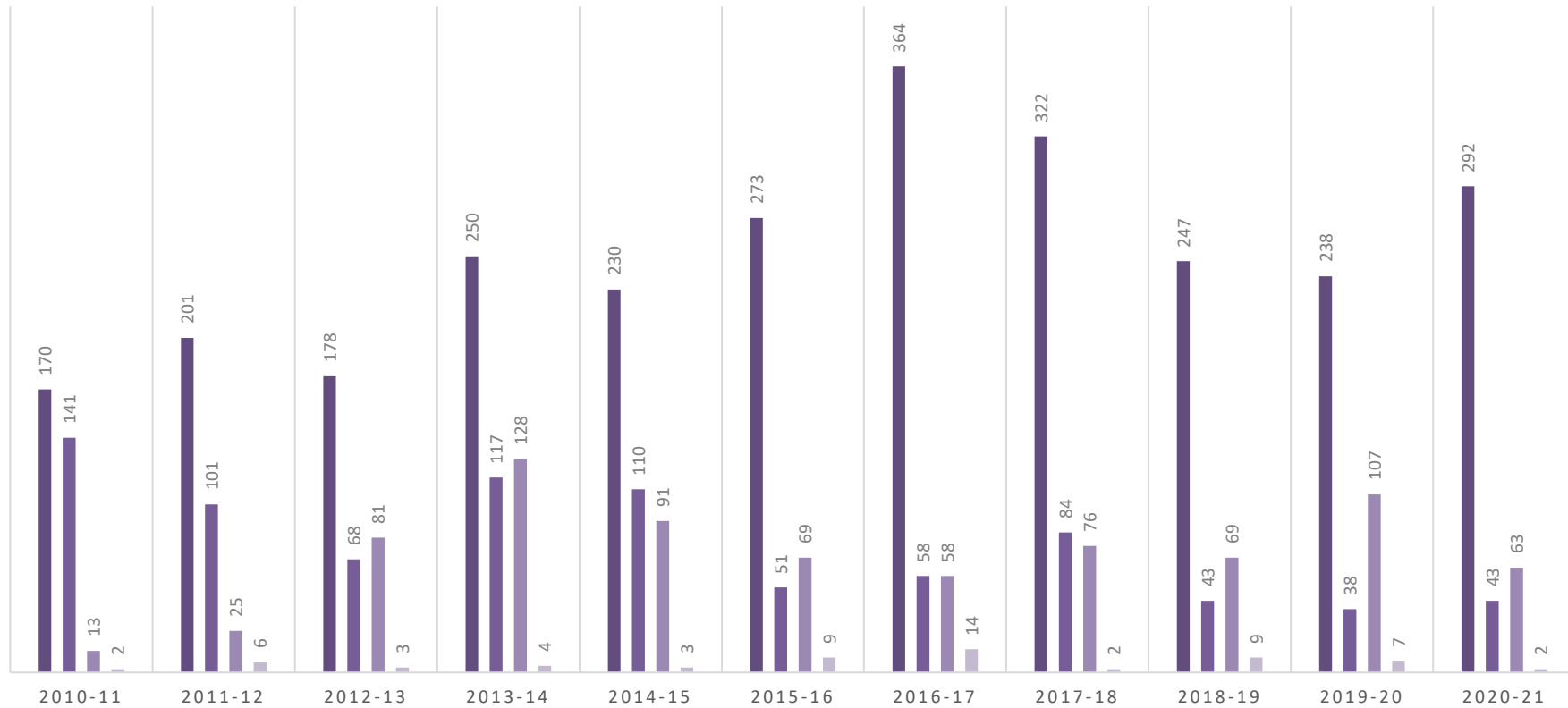

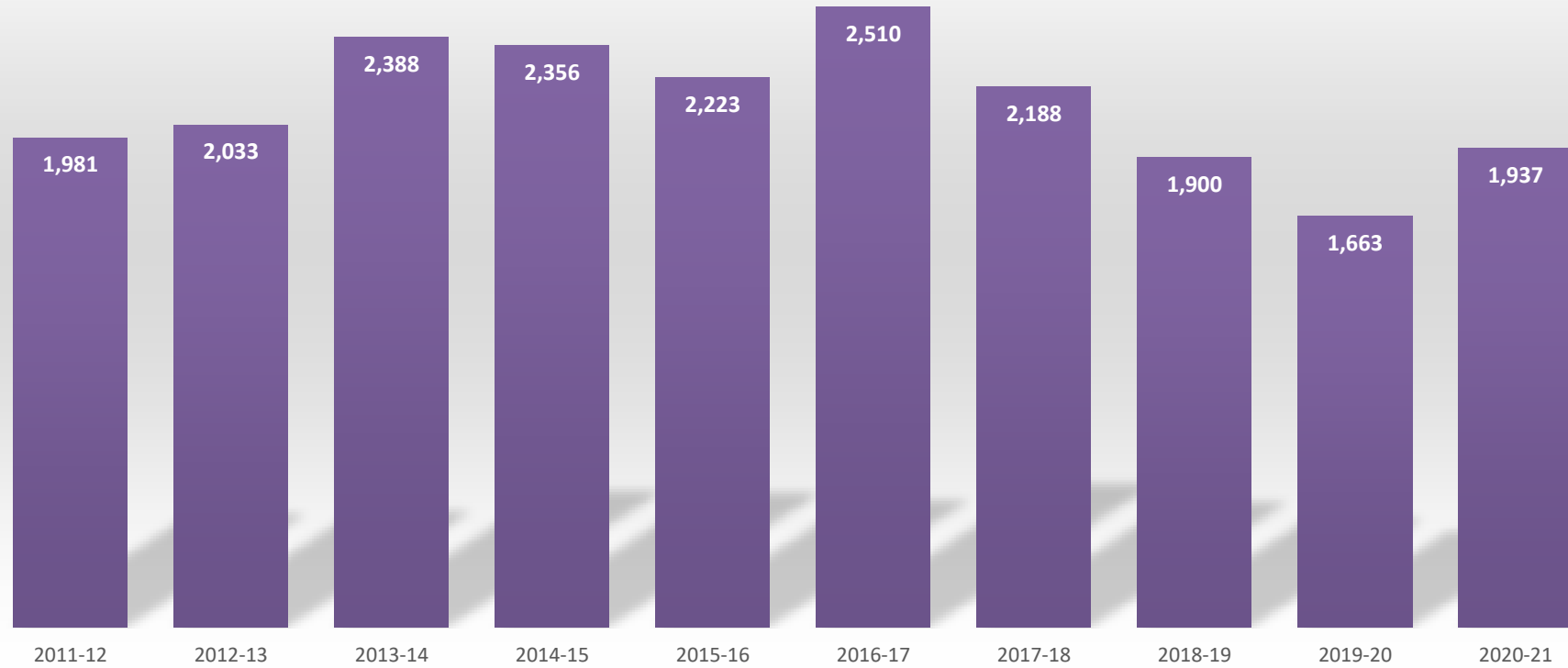
